**Section A: Definitions**

"Interest in any firm in the Hired Truck Program" means any ownership or beneficial interest in any firm in the Hired Truck Program, whether direct or indirect, and any other financial or economic interest in any hired trucks or equipment doing business with the City of Chicago.
