City of Chicago Used Vehicle and Equipment Public Auction Affidavit

Section A: Definitions

"Person" means any individual, entity, corporation, partnership, firm, association, union, trust, estate, as well as any parent or subsidiary of any of the foregoing, whether or not operated for profit.

"Relative" means a person who is related to the person completing this document as spouse or domestic partner, or as any of the following, whether by blood or by adoption: parent, child, brother or sister, munt or uncle, niece or nephew, grandparent, grandchild, father-in-law, mother-in-law, son-in-law, daughter-in-law, sister-in-law, brother-in-law, stepfather or stepmother, stepson or stepdaughter, stepbrother or stepsister, half-brother or half-sister.

"Interest in any firm in the Hired Truck Program" means any ownership or beneficial interest in any firm in the Hired Truck Program, whether direct or indirect, and any other financial or economic interest in any hired trucks or equipment doing business with the City of Chicago.
