### **Internal Revenue Service (IRS) – Tax Fraud**

- ★ Tax Fraud: If you suspect an individual or a business is not complying with the tax laws, a **confidential** tax fraud report can be filed. A reward can also be claimed for information about tax fraud.
- ★ Tax Fraud includes:
  - ★ False exemptions or deductions
  - ★ Kickbacks
  - ★ Failure to pay taxes
  - ★ Unreported Income
  - ★ A false or Altered document
  - ★ Failure to withhold taxes
  - ★ Failure to follow tax laws
