### **PUBLIC VEHICLE INDUSTRY NOTICE**

### **NEW PEDICAB MUSIC/NOISE/SOUND RESTRICTIONS**

As of **March 6, 2022**, the following new law is in effect:

1. From 10pm to 8am: a pedicab may NOT amplify music, noise, or sound.
2. From 8am to 10pm: a pedicab may ONLY amplify music, noise, or sound when transporting passengers.

A violation of this law is subject to a fine between \$100.00 and \$500.00 per offense.

#### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** Section 9-110-150 of the Municipal Code of the City of Chicago is hereby amended by deleting the language stricken through and inserting the language underscored, as follows:


#### **9-110-150 Operating regulations.**

*(Omitted text unaffected by this ordinance)*

(d) Reserved. No person operating a pedicab on the public way shall employ any device or instrument that amplifies sound, including, but not limited to, any loudspeaker, bullhorn, amplifier, public address system, radio or device that plays recorded music, to generate any sound for the purpose of communication or entertainment, except between the hours of 8:00 A.M. and 10:00 P.M. while such pedicab is actively providing transportation to passengers.

*(Omitted text unaffected by this ordinance)*

**SECTION 2.** This ordinance shall take effect 10 days after passage and publication.
