# STEPS TO TIMELY RENEW A LIVERY VEHICLE LICENSE

**Current Livery Vehicle Licenses expire on December 31, 2024**. Please carefully read the following information to timely renew your Livery Vehicle License for the January 1 – December 31, 2025 license term. Failure to follow instructions or checklists will result in delays for license renewals.

- ✓ BACP recommends submitting application before December 13, 2024, to ensure timely renewal.
- ✓ Only an individual licensee, a registered corporate officer or LLC member, or an Illinois-licensed attorney authorized by the licensee may renew on behalf of the licensee. Your application must be completed and signed by an authorized representative of your business.
- ✓ A license must be renewed before the expiration date in order to continue licensed operations. Refer to Chapter 9-114 of the Chicago Municipal Code at <a href="mailto:amlegal.com">amlegal.com</a>.
- ✓ Licenses who complete their 2025 renewal will be issued a license hard card with the name and number of the livery vehicle license. This license hard card must be displayed on the passenger side dashboard.
- ✓ The license will not be issued until renewal application is completed and the \$500 license fee is paid.
- ✓ **NEW**: Pay online at **ChiPay.Chicago.gov** obtain IRIS and Charge ID numbers from payment coupon.

## Important dates to note:

- BACP offices are closed: Nov. 11, 2024, Nov. 28, 2024, Dec. 25, 2024, and Jan. 1, 2025.
- **Up to December 13, 2024**, the Public Vehicle Licensing Operations Facility at 2350 W. Ogden Avenue, 1st Floor, Chicago, IL 60608 is open to walk-ins without appointments from 8:30 am to 11:30 am only. After 11:30 am is **by appointment only.**
- From December 16, 2024 to January 10, 2025, the Public Vehicle Licensing Operations Facility will provide service by appointment only.
- On January 13, 2025, the Public Vehicle Licensing Operations Facility will resume accepting walk-ins without appointments from 8:30am to 11:30am. After 11:30 am is by appointment only.

STEP 1: READ AND FOLLOW THE <u>2025 LIVERY VEHICLE LICENSE INSTRUCTIONS AND CHECKLIST</u>
POSTED ON THE <u>BACP LIVERY WEBPAGE</u> (start at <u>Chicago.gov/PublicVehicles</u> ⇒ click "Chicago Public Passenger Vehicle Licenses (Other than Taxi and TNP/Ride-Hail)" ⇒ click "Livery")

# STEP 2: OBTAIN LICENSE RENEWAL & OWNERSHIP VERIFICATION FORM ASSOCIATED WITH YOUR IRIS ACCOUNT.

- Note: This form is personalized for each IRIS account and is NOT posted on the BACP webpage.
- There are two ways to obtain this form and the scheduled inspections for the vehicles listed on your IRIS account: (1) in-person at the BACP Public Vehicle Licensing Facility OR (2) by sending a request to <a href="mailto:BACPPV@cityofchicago.org">BACPPV@cityofchicago.org</a> for the form to be emailed to you. Licensees must state in the email subject line: "Request for Livery Vehicle License Renewal Form" and include licensee name, license number, and/or IRIS number in email. All communications with BACP must include this information.

# STEP 3: RESOLVE CITY OF CHICAGO DEBT AND LICENSE ACCOUNT HOLDS ONLINE AND ENSURE LICENSE ACCOUNT IS IN GOOD STANDING AT Chicago.gov/ChicagoBusinessDirect

- If you have not yet registered and created a personal user profile for yourself, please do so. If you already established your personal user profile, then please log in.
- Proceed to your MY BUSINESS ACCOUNTS page to <u>ensure</u> that your personal user profile is linked to your livery license business account. If you are not linked, please email ChicagoBusinessDirect@cityofchicago.org.
- Proceed to the TAX SERVICES section to file your GTT (ground transportation tax) return.
- Pay unpaid charges and balances associated with your livery license business account.
- Make sure outstanding balances are paid and City of Chicago tax return filings are current.
- Questions regarding City of Chicago taxes and tax return filings may be directed the Department of Finance at <a href="mailto:revenuecs@cityofchicago.org">revenuecs@cityofchicago.org</a> or (312) 747-4747.
- BACP cannot process a license renewal if the license account has holds or debt.

STEP 4: VISIT ilsos.gov TO OBTAIN THE CORPORATTION OR LLC PROOF OF "ACTIVE" STATUS DATED AFTER OCTOBER 1, 2024. Include the "Officers" or "Managers" tab. Officer/Manager information listed must match information on file with BACP. Screen shots of ilsos.gov webpages will be accepted.

#### STEP 5: CONFIRM CURRENT CERTIFICATE OF INSURANCE PER LIVERY VEHICLE IS FILED WITH BACP

#### STEP 6: SUBMIT COMPLETE LICENSE RENEWAL PACKET CORRECTLY TO BACP.

- (1) Email to **BACPPV@cityofchicago.org** the preferred method, OR
  - Email must contain applicant's name, livery vehicle license number, and IRIS number.
- (2) In person at the BACP Public Vehicle Licensing Facility (2350 W. Ogden, 1st Floor, Chicago, Illinois)
  - Appear at your <u>Scheduled IN-PERSON Appointment for Livery Vehicle License Renewal.</u>
  - If you do not appear at your scheduled in-person renewal appointment, you will be considered a "walk-in". Walk-ins must check in at the reception desk before 11:30am or schedule an appointment.

### STEP 7: PAY THE LICENSE RENEWAL FEE: \$500.00 for a one-year license term.

• NEW: Pay online at ChiPay.Chicago.gov - obtain IRIS and Charge ID numbers from payment coupon.

#### STEP 8: PICK UP THE 2025 CITY OF CHICAGO LIVERY LICENSE "HARD" CARD

- Display the 2025 City of Chicago Livery "Hard" Card on passenger-side dashboard when operating.
- Purchase 2025 City of Chicago Livery License Plates from the Illinois Secretary of State.
- Look up <u>scheduled livery inspection dates</u> for 2025 and take your vehicle to scheduled inspection at the BACP Public Vehicle Inspection Facility at 2420 W. Pershing Road.
