

MODIFY DISTRICT BYLAWS TO ENSURE NOMINATOR CONTINUITY
DURING A NOMINATING CYCLE

PROPOSED BY AISHA HUMPHRIES 006

ADOPTED

What is your proposal and why do you think it should be a priority item? Please name the problem you hope to address and any goals/outcomes you hope to achieve.

I'm proposing that each District Council modify their bylaws as needed to ensure that changes in the Nominating Committee position do not occur during a Nominating cycle.

Some district councils set up bylaws to allow for rotation of members at designated times.

The ECPS ordinance also sets a timeline for the nominating process, including the number of days allowed for position marketing, candidate review, and nominee submission to the mayor. If the mayor does not approve a sufficient number of candidates, and/or City Council does not vote on all submitted candidates, then the timeline can extend from 90 days to several months.

During the 2024 process, the nominating timeline and the timeline of some district councils did not align. As a result, new members joined the Nominating Committee after the candidates had been selected and nominated. New members had very little opportunity to learn about the process, the candidates, or the issues involved with getting nominees approved.

I am proposing that District Councils amend bylaws to state that Nominating Committee members should remain in their roles during a Nominating cycle. A cycle would be defined as the period between the application submission deadline for new Commissioners, and the date of final approval by the mayor's office and City Council. If this period exceeds a certain time frame (as in the current environment, where it's been more than six months), Committee members can switch roles after the mayor has submitted approved names to the City Council.

I would welcome feedback on this, especially from our Nominating Committee attorneys and CCPSA staff.

How does your proposal help advance the purpose or work of the District Councils?

This advances the work of the Nominating Committee by ensuring continuity during the review and selection process.

**ELECT DISTRICT COUNCILORS TO A WORK GROUP FOCUSED ON
CCPSA STAFF ACCOUNTABILITY**

PROPOSED BY ERIN VOGEL 009

ADOPTED

What is your proposal and why do you think it should be a priority item? Please name the problem you hope to address and any goals/outcomes you hope to achieve.

The intention of this proposal is to create a working group elected by District Councilors focused on CCPSA staff accountability. The working group will review, inform, and evaluate the fulfillment of staff responsibilities and subsequently deliver the findings and recommendations to the Commission in an annual report.

Currently, there is not an organized, transparent process for District Councilors and Commissioners to evaluate all levels of CCPSA staff nor are there accountability guidelines and accessible performance assessments. The purpose of the annual report to the Commission, is to provide the Commission with information on the performance of staff for District Councilors, as the Commission carries out its responsibility under section 02-80-020 of the Municipal Code of Chicago to evaluate the Executive Director and set the direction for improvements of CCPSA staff.

The intention of this proposal also calls upon the Commission to formalize and carry out annual performance assessments of the Executive Director and CCPSA staff in a manner that invites input from the District Councils.

The goals of this working group would be to create both qualitative and quantitative processes for accessing CCPSA staff on every level and deliver an annual report to the Commission detailing findings and recommendations.

Additional outcomes would include:

- Clear delineations and descriptions of CCPSA staff roles and expectations provided to District Councilors
- Collection of unfettered information from all District Councilors on how staff services have been delivered and their experiences with CCPSA staff
- An established schedule for this process including a clear calendar to report the findings

to the Commission in conjunction with the budget season (goal to submit by June) so that the Commission may evaluate future budgetary and personnel needs

- Establishment of an elected working group

How does your proposal help advance the purpose or work of the District Councils?

With respect to all parts of CCPSA—from District Councilors to Commissioners to CCPSA staff—a clear understanding will help all of us work together to uplift the intentions of the CCPSA Ordinance.

This proposal would help advance the work as District Councilors in the following ways:

- Help guide future improvements in staff performance
- Identify opportunities for improving CCPSA operations through the city's annual budget proposal process
- Raise Commission awareness of the challenges faced by District Councilors and how staffing can help overcome those challenges
- Develop better communications and working relationships between District Councils and staff, including better problem solving and setting clear, achievable, and appropriate expectations for staff support.

DISTRICT COUNCIL ACCOUNTABILITY AND CENSURE

PROPOSED BY CHRIS LAURENT 014

NOT ADOPTED

September 15, 2024

Whereas, The Community Commission for Public Safety and Accountability (CCPSA) and the Police District Councils have a public duty, outlined in the Municipal Code of Chicago, 2-80-070(a) and (e), specifically, "Building stronger connections between the police and the community at the district level."

Whereas Councilor David Orlikoff, who currently serves as the Community Outreach representative of the 14th Police District Council, has direct communication with members of the community, is viewed as the voice of the 14th Police District Council and continues to provide messaging counterintuitive to promoting the mission and goals of the CCPSA when he stated in an email to all CCPSA staff and personnel "Our job is to pass policies for CPD to follow. Not to follow their lead." This is a further violation of the Municipal Code of Chicago, 2-80-150, labeled Retaliation, obstruction or interference (specifically section (a), which states "No person shall retaliate against, punish, intimidate, discourage, threaten, or penalize any other person who serves or seeks to serve as a member of the Commission or District Councils, or participates or seeks to participate, in any capacity, in the work of the Commission or District Councils. No person shall knowingly interfere with or obstruct the Commission as the Commission carries out its powers and duties under this chapter.");

Whereas for his time in office Councilor Orlikoff has continued to mistreat members of the CCPSA staff, launch vitriols against his District Council colleagues in a disrespectful manner and community partners he views as beneath him, a violation of the 14th Police District Council bylaws (Art. V, Section B) City of Chicago's personnel rules;

Whereas on April 6, 2024, Councilor Orlikoff assaulted a colleague during a public monthly meeting which was clearly documented in a news article and a sustained video; and

Whereas these actions of Councilor Orlikoff have aggrieved and office of elected Police District Councilor and his colleagues in the behavior this body deems reprehensible:

Now, therefore, be it *Resolved*, That—

- (1) the Community Commission for Public Safety and Accountability's Police District Council city-wide members censures David Orlikoff, Police District Councilor of the 14th Police District of Chicago, for conduct unbecoming of an elected Police District Councilor;
- (2) Councilor David Orlikoff will forthwith present himself in the well of the Quarterly Meeting for the pronouncement of censure;
- (3) Councilor David Orlikoff will be censured with the public reading of this resolution by the Chair Pro Tempe; and
- (4) under MCC 2-80-030, specifically item (7) *encourage preventative, proactive, community-based, and evidence-based approaches to public safety*, the Community Commission for Public Safety and Accountability shall conduct an investigation into Councilor David Orlikoff's conduct, misrepresentations, and abuses of his office, with all findings, determinations and suggested corrective action to be forwarded to the Chicago Board of Ethics and the Office of Inspector General.
