16. What do you think are the most important accountability and/or public safety issues facing the 17th Police District and how will you work on them? *

As a criminal defense attorney I have witnessed firsthand the devastating effects of violence in our city, but I have also seen the harmful impacts of police misconduct and tactical enforcement policing strategies which are heavily dependent upon intrusive and discriminatory pretextual investigative stops. These abuses are extremely counterproductive because they undermine public trust between law enforcement and the communities that they serve. Law enforcement officers cannot effectively investigate and prevent crime and violence if they don't have input from the citizenry at large. Conversely, the citizenry cannot make informed judgments about the effectiveness of their police department, and their willingness to cooperate with modernization efforts, if they are not provided with a candid, accurate, and accessible flow of information.

As a member of the CPD 17th Police District Council I would work tirelessly to maintain communication with the public and the police department, so that I can stay informed about the specific needs and concerns of the community and monitor the progress and outcomes of our current policing strategies and directives. I would pay especially close attention to ensure that our rank and file sworn officers are adequately trained and encouraged to facilitate alternative policing strategies such as cooperating with the work of specialty courts, helping to facilitate services for victims of crimes, and screening and flagging juveniles and emerging adults for deferral programs.
