## 15. Why do you want to serve as a District Council Member in the 17th Police District? \*

#### 250 word limit

I have been a community organizer since 2006. During that time, I have organized in both English and Spanish, in neighborhoods like Pilsen and Albany Park. Whether organizing with undocumented youth or with election campaigns, the topic of police accountability has always been present: especially after the summer of 2020.

An important thread that always ran through these organizing experiences is that people feel safer when they get to know each other, their neighbors, their community. # 16. What do you think are the most important accountability and/or public safety issues facing the 17th Police District and how will you work on them? \*

#### 250 word limit

The most immediate accountability issue in 17th District is the presence of Oath Keepers in CPD. With political polarization on the rise, having right-wing extremists in uniform is a clear and present danger for all Chicagoans. Shining a light on this issue, and making communities aware of it, would be a top priority for me as a District Councilor.

Public safety issues around gangs are a long-standing issue that the police are ill-equipped to confront. I would make it a priority to focus on working with violence interrupters to prevent or de-escalate violence. Again, public safety is also about getting the community out and together. To that end, I would help organize "space activations" and other events to bring the communities out, especially in areas where violence have recently occurred, to get people talking to each other and rebuilding a sense of confidence and ownership over a given block or neighborhood.

In addition, these accountability and public safety issues can also be opportunities to pull in neighborhood organizations to participate and help get more groups involved in contributing to our safer communities.
