- CPD Command Staff has noticed decrease in activity here
- They have had success in arresting a few criminal teams (some even in the act)
- Criminal teams had been shifting hours when they would commit burglaries and CPD would have to adjust their tactical teams accordingly
- CPD Officers DO have ability to chase, but judgment call by officer

### Meeting Highlight: Office of Emergency Management and Communication (OEMC)



The Office of Emergency Management and Communications coordinates the city's public safety and emergency response efforts, including 911 and 311 call handling, emergency management, traffic management, and disaster preparedness.


Created to ensure seamless communication between first responders, manage large-scale events, and prepare for potential crises, such as severe weather or public safety threats.

OEMC also operates the city's Emergency Operations Center and facilitates public safety technology, including real-time camera feeds and public alert systems.

- The current ones are very outdated

019 PDC Website Resource Page	Maurilio designed and built out our website with tons of resources related to various topics, making them all readily available for public consumption (and easy to find!)
019 Roll Calls	Attended CPD Roll Calls at the 019 Town Hall to get to know our officers, introduce ourselves and the DC position, and pass out our Mental Health Palm Cards.
CCPSA Priority to Explore Alternative Response	Jenny drafted and passed a goal on behalf of our Council so that our CCPSA Commissioners focus on and prioritize our initiative to create an Alternative Response Model in Chicago. We look forward to continuing to work with the Commissioners to find the best past forward here.
Data Analytics Working Group	Maurilio formed a team of dedicated volunteers to help dig into the many data sources available to the community, and played an instrumental role in our 911 Calls for Analyses initiative (with more to come).
Mental Health Palm Cards	Jenny enrolled key mental health organizations in our neighborhood and led the design and creation of our Mental Health Palm Cards. More than 1,500 have been distributed!
Neighborhood Groups Networking Event	Organized a networking event with many of the 19th District's neighborhood groups so members could get to know one another and share information. It was a very positive engagement!

# Notable 2024 Accomplishments

Nominating Committee CCPSA Appointments	Sam helped lead design, structure, and implementation of first ever nomination process of CCPSA Commissioner appointments and successfully nominated the first permanent Commissioners.
Refinement of our Role as District Councilors	As part of the first-ever class of District Councilors, we made terrific progress in defining our role in ways that we believe will make meaningful change in our public safety system, while advocating for the needs expressed by our community. We now work to address the immediate needs of our community, while remaining focused on long term strategies that will help address some root cause issues. We also take enormous pride in our constant push for positive relationship building with all stakeholders involved with our work.
Strengthening District Councils via OMA Reform	Sam continues to work with state legislators to revisit the Open Meetings Act so that District Councils across the city can function more effectively.
Strong Relationships with Alders, Elected Officials, and CPD Command Staff	We've maintained and bolstered relationships with many of the stakeholders involved in completing our work. We are very fortunate to have great leaders in our district that help us better understand our public safety landscape, while offering their guidance and help. Thank you!
Workforce Allocation (WFA) Study	Continued to push and advocate for the implementation of the WFA Study, which was passed UNANIMOUSLY in City Council after Ald. Martin's introduction. The contract was delayed, but recently signed into action. We look forward to providing our community's feedback into the creation of this study!
