**District Council Member Updates:**

**Kennedy-** The Commission is actively accepting and reviewing applications to fill multiple vacancies on the Police Board. The term is five years, and each board member receives a monthly stipend of \$1000. Saturday, October 26<sup>th</sup> from 9-11AM the 22<sup>nd</sup> District CAPS Subcommittee on Domestic Violence invites you to “Dance Away Domestic Violence” at Ridge Park, 9625 S. Longwood, Chicago with Line Dance Lessons from Dancing Mary. Community Policing will be holding “Community Conversation” to create the 2025 strategic plan. The 1<sup>st</sup> conversation

Homicide - Up 27% (14 compared to 11)

Shootings - Down 6%

Robberies - Down 28%

Carjackings - Down 9%

Burglaries - Down 25%

YTD Guns Recovered in the 22<sup>nd</sup> District (407) - Up 25%

**Parker-** Wants to figure out how to better engage residents and make meetings more meaningful.

**Bielecki-** Nominating committee update – Application process to replace Kelly Presley started Oct 7th. 30-day application process. West side attorney needed to fulfill position. Quarterly meeting update – on proposals. Living with Purpose youth conference update.

**Judge Blakely-** 6<sup>th</sup> District, felony matters, 3 years prior domestic violence. There's a 24-hour hotline for order of protection. There are domestic violence advocates at every courthouse. Spoke about different orders.

**Commander-** Clearance rates on robberies 50%. SDSC and detectives working together to accomplish these results. Spoke are the school Sgt. And they will still be responding to school issues. CPD has completed 15 lock down drills at schools this year. 22<sup>nd</sup> District Community Conversations Oct 23<sup>rd</sup> and Nov 12<sup>th</sup>. Working to identify community problems.
