


# **Commissioner's Update**

## **X** 2024 Cases of Measles in Chicago

- No new cases since 4/16/24
- Last exposure at a New Arrivals shelter: 4/5/24
- Last community exposure: 4/16/24

No new cases in >42 days

## **Rise in Recent Overdoses**

- An increased number of drug overdoses have occurred in the Chicago area beginning Saturday, May 11, 2024, and remained high on Monday, May 13, 2024
  - Over 50 overdoses in a 24-hour period
- Opioid-related overdose EMS responses during the spike were concentrated in Chicago's West Side, particularly:
  - Austin, East Garfield Park, Humboldt Park, North Lawndale, and West Garfield Park
- The drug supply has become very volatile
  - We have seen fentanyl, xylazine, nitazenes, and benzopdiazepines.
  - The novel adulterant medetomidine is present as of May 11, 2024

#### Summary and Action Items

• Multiple drug samples collected from the West Side of Chicago on May 11, 2024 tested positive for elevated levels of medetomidine. In addition, fentanyl, heroin, xylazine, alprazolam and nitazenes have been detected in the same samples.


 Medetomidine is a new adulterant in Chicago's drug supply. It is a non-opioid sedative like xylazine but considered more potent. It has no approved use in humans.

Like its dextro-isomer dexmedetomidine (sold as Precedex® or Dexdor®), medetomidine acts on alpha-2-adrenergic receptors to cause sedation, analgesia, bradycardia, prolonged hypotension following initial hypertension, and peripheral vasoconstriction. It can also cause respiratory depression, which can be greater when taken with other opioid and non-opioid sedatives.
 Report overdoses with atypical features to the Illinois Poison Center – 1-800-222-1222 to send

specimen for testing.

 Initiate all patients whose overdose was reversed with naloxone on medication for opioid use disorder (MOUD) before discharge from ED or hospital. MAR NOW is Illinois' immediate opioid treatment helpline. Call 833-234-6343 or text "HELP" to 833234.


## **X** Increase in Opioid Overdoses in Chicago

### Fatal opioid-related overdoses disproportionately impact Non-Hispanic Black males aged 45-64





## Most Impacted Communities

**Every community area** in Chicago had an opioidrelated overdose EMS response (fatal or nonfatal) in **2021, 2022, and 2023** 

However, **West Side community areas** are the most impacted

In 2023, **34%** of opioid-related overdose EMS responses occurred in **5 West Side Community Areas:** Austin, East Garfield Park, Humboldt Park, North Lawndale, & West Garfield Park





## **Hyperlocal Analysis of West Side EMS Responses**

In 2023, "Hot Spots" on the West Side included:


- Pulaski corridor, from Lake to I-290
- Chicago Ave corridor, near Homan
- Area near Pulaski & Division
- Madison corridor, Kedzie to Sacramento
- Harrison corridor, near California
- Roosevelt corridor, Pulaski to California
- Cicero corridor, Madison to I-290
- Area near Central & Lake
- Madison corridor, Central to Laramie

### Location types

Citywide: Streets & Roads = 46% Private Residence = 31% Public Transit = 9%

West Side: **Streets & Roads = 57%** Private Residence = 23% Public Transit = 7%

\*Location of incident has a seasonal trend, with more incidents occurring outdoors in warmer months.





### <u>Goal</u>

## In all 5 West Side neighborhoods:

- Every household should have Narcan
- Every person should be aware of MAR NOW

To reduce the number of fatal overdoses by 50%



## **CDPH's Summer Strategy**

- CDPH has launched an emergency response with an incident command structure led by the Office of Substance Use's Medical Director
- Prioritized efforts:
  - Distributing Narcan to every household
  - Street outreach in collaboration with Westside taskforce and IDHS
  - Educational campaign on Medication-assisted recovery (MAR) NOW, the 24/7 Helpline for Opioids and other substances treatment prescription
  - Health alert to all healthcare providers to initiate all patients who overdose on medication for opioid use disorder before discharge in addition to Narcan
  - Free harm reduction training including how to use Narcan for the public every last Friday of the month
  - Mobilize community, county, state and federal partners including CDC EpiAid

### **Investment in Community Infrastructure**

- The Chicago Department of Public Health's (CDPH) mission is to work with communities and partners to create an
  equitable, resilient, safe, and Healthy Chicago. Our efforts build toward our vision where everyone in Chicago thrives and
  achieves their optimal health and wellness. CDPH's approach is guided by our community health improvement plan,
  Healthy Chicago 2025 that is focused on racial and health equity, especially eliminating Chicago's racial life
  expectancy gap.
- Delegate agency funding is \$173,915,716 of the 2023 total budget
- CDPH has ~283 Active Delegate Agency Contracts, and ~140 different Delegate Agencies
- Major programs include HIV, Mental Health, Violence Prevention, Maternal Health and Chronic Disease



### **Investment in Community Infrastructure**

#### CDPH has successfully:

- Expanded the capacity of federally qualified health centers (FQHCs) to deliver trauma-informed and integrated mental health services.
- Expanded the capacity of community mental health centers (CMHCs) and other community-based organizations to deliver trauma-informed mental health services that are coordinated with the patient's medical home.
- Funded partnerships between FQHCs and CMHCs or other community-based organizations.
- Assisted households to be able to maintain a stable living environment in housing that is safe, decent, and sanitary; reduced the risk of homelessness among persons living with HIV; and improved access to HIV treatment and other related support services.
- Convened, developed, and supported a cohort of community-based organizations (CBOs) that have experience delivering street outreach services specifically aimed at preventing gun violence and forming productive connections between these CBOs and systems partners such as law enforcement and academic institutions.
- Expanded evidence-based treatment options and improved linkages to treatment for people living with substance use disorders and/or cooccurring disorders.

CDPH has been able to tremendous impact in the following neighborhoods because of these investments:

Auburn Gresham, Austin, Chicago Lawn, East Garfield Park, Englewood, Greater Grand Crossing, Humboldt Park, New City, North Lawndale, Roseland, South Lawndale, South Shore, West Englewood, West Garfield Park and West Pullman.
