


# **Accreditation (PHAB) Updates**


 PHAB groups public health services into 10 domains





### **115 Documents**

- Each domain includes Standards and Measures that describe more specific achievements expected of CDPH
- We submit documentation to confirm how CDPH's work meets these expectations
- In total, PHAB requires 115 documents



# **Example**

- Domain 2: Investigate, diagnose, and address health problems and hazards affecting the population
- Standard 2.2: Prepare for and respond to emergencies
- Measure 2.2.7: Conduct exercises and use After Action Reports (AARs) to improve preparedness and response
- Documentation for 2.2.7 includes:
  - Slide deck: Summer Opioid Response Incident Command Structure (SOR-ICS) After Action Report, September 2024
  - Executive Summary: 2024 Summer Opioid Response
  - News article: "Chicago Sees Steep Drop in Number of Deaths Tied to Opioid Overdoses," <u>Journal of Emergency Medical Services</u>, Oct. 6, 2024

- Dec. 9: Complete final review of all documents
- Dec. 16: Finish formatting documents per PHAB submission requirements
- Jan. 6: Finish submitting documents in PHAB portal


# And Then!

- Celebration PHAB submission
  - Thank the staff in 12 bureaus and dozens of programs who provided documentation
  - Thank the 26 staff who reviewed documents for compliance with requirements and recommended improvements
  - Thank leadership for championing reaccreditation
- Review lessons learned
  - Review the process:
    - Timeline, communication, file management, tracking, recordkeeping, project staffing
  - Review the product:
    - How robust is our documentation? Does it do justice to the quality of CDPH's services?
    - Does the documentation represent the breadth of CDPH? Are bureaus and programs underrepresented?
    - What quality improvement needs does it signal?




### **X** All Staff Demographic Dashboard

#### By Gender




#### Equity Dashboard: City of Chicago's Workforce Diversity


Total number of employees in department(s): 757

#### Median Salary by Gender & Ethnicity






Equity Dashboard: City of Chicago's Workforce Diversity

#### PlayStreets 2023:

- 2 delegate agencies, at \$122,500 each, a total of \$245,000 Corporate funds.
- Community Safety Coordination Center (CSCC)
   collaboration \$63,000 investment expanded Playstreets CA's and # of events.
- 30 implementing CBOs.
- 6 events per agency, a total of 180 events held.
- 27 Community Areas through-out the South and West side of Chicago.
- 27,000 participants served.





#### **PlayStreets 2024:**

- CDPH funds two delegate agencies, BUILD, Inc. & Phalanx Family Services.
- CSCC collaboration of \$100,000 investment expanded Community Area (CA) coverage and # of events.
- 30 Community-Based Organizations host 210 events throughout the summer on the West and South side of Chicago.
- We prioritize 38 CA through the Life Expectancy Gap data.
- Over 33,000 participants attended PlayStreets events this year.

These events could not happen without the support and collaborations from CDPH programs, and Sister City agencies.
