First Deputy Commissioner Wagaw provided the following department wide COVID and non-COVID updates:

Measles Update

 There have been no new Measles cases since the last community exposure on April 16th, 2024. A CDPH report published by the CDC projected a high probability of an outbreak of over 100 cases without the City's rapid intervention.

• Rise in Drug Overdoses

- A recent spike of Opioid-related overdoses occurred in the Chicago area from May 11 – May 13, 2024. The rise of overdoses concentrated in Chicago's West Side stems from a volatile drug supply that includes the novel adulterant medetomidine.
- $\circ~$ CDPH issued a HAN on May $20^{\text{th}},\,2024,\,\text{regarding}$ Medetomidine in Chicago's drug supply.
- CDPH used Chicago Fire Department data for a hyperlocal analysis of West Side EMS responses to identify opioid overdose hotspots.

• Opioid Response Summer Strategy

- o CDPH launched an emergency response Incident Command Structure led by the Office of Substance Use Medical Director.
- Objectives in the emergency response include:
 - Distribution of Narcan to every household.
 - Street outreach with Westside taskforce and IDHS.
 - Education campaign on Medication-assisted recovery (MAR).
 - 24/7 Helpline for opioids and other substances.
 - Health alert to healthcare providers to initiate medications for opioid use disorder for overdose patients before discharge.
 - Free monthly harm reduction training for the public.
 - Mobilize community, county, state and federal partners including CDC EpiAid.
