Application Information

2025 marks the 46th anniversary of the Chicago Farmers Markets Program. Currently, there are two city run markets and four community partner run markets that sell produce alongside prepared foods and local, artisan products. There are approximately 50 independent Markets operating in Chicago as well.

Farmers Markets are dynamic platforms for local entrepreneurs, providing an excellent opportunity for farmers, artists, and businesses to showcase their products. Joining our markets means engaging with a vibrant community, promoting entrepreneurship, and contributing to the well-being of Chicago residents through the sale of fresh, diverse produce. Our markets actively support vendors and their communities, including under-resourced individuals through SNAP programs, ensuring equitable access to quality, locally sourced food. We welcome you to become a part of this thriving ecosystem, where your participation not only boosts your business but also enhances the social and economic fabric of Chicago.

Vendor Eligibility

All vendors must apply annually; approved selling privileges are valid for a single growing season. A link to the application can be found on last page of this document. Admission is based on the applicant's strengths in the following areas (in order of priority):



Vendor's history with DCASE Markets (including adherence to market rules and regulations, market attendance, history of positive consumer/producer relationships, payment of fees, and professional behavior).



Products are locally grown, have seasonal integrity and are of high quality.



Uniqueness of products offered that enhance the market and enrich shopper experience.



Ability to engage and educate consumers about products and how they were produced (via knowledgeable employees, informative brochures and handouts, etc.)

Insurance Requirement

All applicants for any Chicago Farmers Market will be required to provide an original Certificate of Insurance evidencing the following insurance minimums for the dates of May 1 to October 31, 2025:

- Workers Compensation and Employers Liability minimum of \$1,000,000 each accident, illness or disease
- Commercial General Liability minimum \$1,000,000 per occurrence
- Automobile Liability minimum of \$1,000,000 per occurrence
- Property coverage (replacement cost)
- Certificate Holder MUST list: City of Chicago, 78 E. Washington, Chicago, IL 60602

Final acceptance is contingent on applicant naming the City of Chicago, the Chicago Park District, their employees, agents and officials as additionally insured. Applicants must also submit a copy of the endorsement using ISO form CG20 26 or equivalent. Applicants' certificate of insurance must also evidence a waiver of subrogation in favor of the City of Chicago, its employees, elected officials, agents or representatives.







Insurance Requirements

Additional insurance: Bronzeville, Daley Plaza and Pullman Market locations have additional insurance requirements. Please make sure that you comply and provide a separate certificate of insurance for each additional market to which you are accepted.

- Copy of 2024 Illinois Sales Tax Filing (for returning vendors, new vendors need ID # only)
- Summer Festival Vendor Sanitation **Certification** (if you are sampling and/or serving food) due after acceptance
- Proof of Commercial Liability Insurance due after acceptance
- Signed Letter of Agreement, Transparency Oath & Disclosure of Indebtedness to the City of Chicago (included in online application)

- 2025 Growing Calendars

LINK/SNAP & LINK Match Coupons (MANDATORY):

All vendors that sell qualified produce at Chicago Farmers Markets where LINK/ SNAP & LINK Match coupons are accepted must participate. We work with a third-party contractor to complete operational and accounting functions, making it very easy for our vendors to participate.

Senior Farmers Market Nutrition Program:

All vendors that sell qualified produce at Chicago Farmers Markets must register with the Illinois Department of Human Services to accept and redeem Senior Produce Coupons.

Please note: All past City of Chicago Farmers Market fees MUST be paid in FULL in order to be reaccepted in to the 2025 markets.

Vendors will be billed per 10'x10' space per day. Details will be provided with your 2025 acceptance letter. Market fee can be billed at any point throughout the season and payment is due upon receipt by the date designated on the invoice. If payment is not received, you may forfeit your space at the market for the next season.
