**WHEREAS**, the Community Development Commission (the "Commission") of the City of Chicago (the "City") has heretofore been appointed by the Mayor of the City with the approval of its City Council (the City Council referred to herein collectively with the Mayor as the "Corporate Authorities") as codified in Section 2-124 of the City's Municipal Code; and

**WHEREAS**, the Commission is empowered by the Corporate Authorities to exercise certain powers enumerated in Section 5/11-74.4-4(k) of the Illinois Tax Increment Allocation Redevelopment Act, as amended (65 ILCS 5/11-74.4-1 et seq.), (as amended from time to time, the "Act"); and

**WHEREAS**, the City Council, upon the Commission's recommendation pursuant to Resolution 22-CDC-10 and pursuant to the Act, enacted three ordinances on July 20, 2022 pursuant to which the City approved and adopted a certain redevelopment plan and project (the "Plan") for the Cicero / Stevenson Redevelopment Project Area (the "Area"), designated the Area as a redevelopment project area and adopted tax increment allocation financing for the Area. The street boundaries of the Area are described on Exhibit A hereto; and

**WHEREAS**, LECLAIRE PARTNERS A—NORTH JV LP OR RELATED ENTITY, together with its affiliates, (the "Developer"), has presented to the City's Department of Planning and Development (the "Department") a proposal for redevelopment of the Area or a portion thereof that is in compliance with the Plan, consisting of the construction of a 2 multi-story, mixed-use, mixed-income buildings with 160 units of which 110 will be in LeClaire North and 50 in LeClaire South (the "Project"); and

**WHEREAS**, DPD requests that the Commission recommend to City Council that the Developer be designated as the developer for the Project and that the Department be authorized to negotiate, execute and deliver a redevelopment agreement with the Developer for the Project; now, therefore,

**BE IT RESOLVED BY THE COMMUNITY DEVELOPMENT COMMISSION OF THE**

**CITY OF CHICAGO:**

- Section 1. The above recitals are incorporated herein and made a part hereof.
- Section 2. The Commission hereby recommends to City Council that the Developer be designated as the developer for the Project and that the Department be authorized to negotiate, execute and deliver on the City's behalf a redevelopment agreement with the Developer for the Project.

## **II. PROPERTY DESCRIPTION**

## **III. BACKGROUND**

The original LeClaire Courts was a public housing development built in 1950 with over 600 two story row houses. The development was torn down in 2011 as part of CHA's then "Plan for Transformation."

After 2 ½ years of discussion with community residents and organizations, the developers submitted applications for the LeClaire North and LeClaire South mixed-use projects as part of the Department of Housing's Qualified Allocation Plan's 2021 funding round. The project which is the subject of this CDC presentation will be the first of up to 725 dwelling units built on the entire LeClaire site. Next year, the developer expects to break ground on the grocery store and medical office building, also part of the Phase 1 development.

## **IV. PROPOSED DEVELOPMENT TEAM**

### **Development Entity:**

LeClaire Partners A-North JV LP will be the owner of the project. This ownership entity will be

comprised of LeClaire Partners A-North JV LLC as the general partner with .01% ownership and a LIHTC investor limited partner (with 99.9% ownership) who will join at closing. The GP is made up in turn of a managing member with 85% ownership and CHA or a CHA affiliate with 15% ownership. Of the managing member, Cabrera Capital Partners, LLC has 65% ownership and the Habitat Company, 35% ownership. The developer's organization chart is included in the exhibits.

Cabrera Capital Partners (CCP) provides commercial and residential real estate development expertise, investment, and consulting services to a full range of clients in the public, private, institutional and non-profit sectors. CCP has experience providing investment advisory services including development, acquisition and management of over \$3.5 billion in institutional real estate.

Habitat is a 50-yr old premier affordable housing developer, owner/operator, and property manager. In 1987, Daniel Levin and The Habitat Company were appointed receiver of the Chicago Housing Authority Scattered Site housing development program by the U.S. District Court in Chicago. In that capacity, Habitat has overseen the citywide public housing revitalization program. They have developed properties that were financed through a broad range of conventional and public financing programs, including tax-exempt bonds, low-income housing tax credits (LIHTC), HOME, CDBG and project-based section 8. The company has become one of the Midwest's largest development and property management companies with operations in Chicago, St. Louis, Detroit, Ann Arbor, and Tampa. Recent projects with the City of Chicago include East Park Apartments/East Park SRO, a 152-unit affordable project at 3300 W. Maypole with a City LIHTC award; 43 Green Phase 1, a 99-unit affordable project at 43<sup>rd</sup> and Calumet which received a HOME loan and LIHTC funding; and part of a JV developing 43 Green, Phase 2, at 311 E. 43<sup>rd</sup>, an 80-unit building also with a HOME loan and LIHTC funding of which more than half the units were affordable.

**Architect:** Knight Engineers and Architects was the original architectural firm and they were acquired by WSP Architects. Going forward with Phase 1, Solomon Cordwell Buenz will be the architect of record.

## **V. PROPOSED PROJECT**

**Project Overview:** The LeClaire North project will consist of 160 units, mixed income housing of which 110 units will be located in the North building and 50 in the LeClaire South building. There will be 14,000 sq. ft of ground floor commercial space in the north building. There will be 123 parking spaces for use by residents of both buildings and 37 bicycle spaces to be used by residents of the North building. There will also be a central courtyard accessible to the public. Both buildings are 6 stories tall. The buildings have a masonry veneer cavity wall system, an insulated metal panel wall system and glazed aluminum framed window system. The first floor commercial space will have a metal framed glazing system. A large panel on each building will be adorned with a mural. Both buildings will front Cicero Avenue with their parking lots to the rear. Both buildings will have a mail room, residential services, flex space, a fitness area, bike room and laundry facilities on the first floor along with commercial space. The 14,000sq. ft of commercial space is expected to be leased by Chicago Commons, a day care provider. The LeClaire South

building has a 2,500 sq. ft. retail space which has yet to be let. The residential units in the north building will be accessible from 44<sup>th</sup> St. and from the parking lot behind the building. The day care center will have an entrance on Cicero and also on the south elevation of the building. The residential units in the south building will be accessible on Cicero and from a door off the parking lot and there will an entrance to the small commercial space off of 45<sup>th</sup> St. on the west side of the building. The parking lots will be at the rear of the buildings and will be accessible from LaCrosse Avenue. The landscaped and vegetated areas on-site will be maximized to the practical extent possible with 15% of the total site landscaped as the set goal.

A site plan, floor plans and elevations are provided as exhibits to this report.

**Residential Unit Profile:** The following table provides a detailed description of the proposed project. The project will provide a total of **160** rental units of which **144** units or **90%** will be affordable for households earning no more than **80%** of the area median income. These units will satisfy the Chicago affordable housing ordinance, which requires 10% affordable units in projects developed on land sold by the City or 20% affordable units in projects receiving TIF assistance.

The affordable rent paid by the tenant is based on the tenant's income, not on market comparables. The maximum rent for each defined "affordable" income level is published annually by the US Department of Housing and Urban Development and listed according to building construction type (i.e. apartment, townhouse, house), number of bedrooms and household size. Rent per square foot is not considered except that HUD housing quality standards and Chicago zoning and building codes set minimum room and unit sizes. Different federal funding development and operating support sources may have different maximum income and rent restrictions.

When developers determine the rent to charge for a project that is using HUD program subsidies through one of the City of Chicago's Multifamily Financing programs, the developer is required to establish market-area rents by commissioning a market study of the targeted market area. The developer is allowed to charge the lesser of HUD-estimated Fair Market Rent or the rent cap by income group (i.e., the 60% rent), but must also take into consideration the localized rent for the development's targeted market area, which is often much lower than the HUD FMR, and may be the same as, or even lower than, the "affordable" rent levels.

#### **Environmental Features:**

The development at LeCLaire Courts will contribute to climate resiliency as follows:

- **Project Management:**

- o Focusing on Environmental Management during construction and Commissioning activities.

- **Site:**

- o Divert 80% Construction Waste from Landfill.

- o Erosion control, storm water management, native species selection with low-water tolerant plants.

- o Reducing light pollution and incorporating Heat Island reduction through highly reflective

roofing membranes and site paving.

- o Opportunity to introduce Green Roof Systems

- o Urban Beekeeping

- **Energy:**

- o Using Highly rated opaque envelope and fenestration to enhance Thermal Resistance performance.

- o Reducing Lighting Power Density and installing controlled switching.

- o Providing a Building Automation System with efficient cooling equipment, air economizers, damper controls, leak prevention measures for fans and ductwork, and a VRF system.

- o Opportunity to introduce Solar Panels at Roof level.

- **Water:**

- o Reduce Water Use by 40%: Achieved by using 0.8 GPF WC // 1.5 GPM shower // 0.5 GPM lavatory faucet // 1.5 GPM kitchen faucet in units.

- o Reduce irrigation through low-water tolerant plantings.

- **Materials and Resources:**

- o Using Environmental Product Declaration (EPD) materials.

- o Reducing waste during construction and operation.

- o Specifying quality materials and installation methods with field inspections including air barriers and vapor retarders.

- **Emissions:**

- o Maintaining the Ozone-Depleting Potential < 0.03 and including leak detection on chillers.

## **VI. FINANCIAL STRUCTURE**

The proposed project consists of 160 rental residential units of which 110 are located in LeClaire North A-North and 50 in the adjacent LeClare A-South building. \$5.5M in TIF funds, which represent 6% of the total project cost, will be used towards construction of these units. TIF funds will be ported from Cicero/Archer and Midway Industrial Corridor TIFs into the Cicero / Stevenson TIF to fund the project. In addition to TIF, the City will loan \$9,316,897 in multi-family funds. The project will be heavily supported by IHDA which will issue \$47,000,000 in bonds that will generate an estimated \$30,253,938 in 4% tax credit equity. IHDA will also provide a soft loan of approximately \$10,858,900. CHA is providing a capital loan of \$27,000,000. Seller financing, accrued construction interest (on the CHA loan), a DCEO grant for predevelopment costs and Donation Tax credit equity round out the funding.

## VII. PUBLIC BENEFITS

The proposed project will provide the following public benefits.

**Affordable Housing:** The project will provide **80** replacement CHA units and 64 additional affordable housing units.

**Property Taxes:** The project will expand the tax base because the investment in the property will result in an increase in its assessed value.

**Permanent Jobs:** The project is estimated to generate **30-40** permanent jobs in **THE DAYCARE LOCATED ON THE FIRST FLOOR OF THE BUILDING.**

**Construction Jobs:** The project will produce **250** temporary construction jobs plus 4-5 compliance monitoring jobs during the course of construction.

**Affirmative Action:** The developer will comply with the requirements of Chicago's affirmative action ordinance, which requires contract participation of 26% by minority-owned business enterprises (MBEs) and 6% by woman-owned business enterprises (WBEs). The developer has provided notification of the proposed project, by certified mail, to several associations of minority and women contractors. A sample version of the letter and copies of the post office receipts for the certified letters are presented as exhibits to this report.

**City Residency:** The developer will comply with the requirements of Chicago's city residency ordinance, which requires that at least half of all construction-worker hours be filled by Chicago residents. The developer will also comply with the requirement that all construction jobs are paid the prevailing wage.

## **VIII. COMMUNITY SUPPORT**

Alderman **MICHAEL D. RODRIGUEZ** endorses the project and has provided a letter of support (see exhibits for copy). The project was presented to the community at over 30 meetings over 6 years. According to the developer, the plans for the proposed project have been well received by the community and the various meetings have generally been well attended. Community residents were pleased with the design and aesthetic of the site plan and are happy that a full-service grocer and healthcare provider have been incorporated into the Phase 1 plan.

Former LeClaire residents were concerned that their priority right to return to the development would be honored and also that the new residential buildings would have adequate tenant screening and property security to ensure the new LeClaire is an asset to Garfield Ridge, not a detriment.

A broad range of community organizations as well as the alderman's office are strong supporters of our redevelopment efforts on the LeClaire Courts redevelopment site. The following community organization(s) (has/have) endorsed the project: **THE SOUTHWEST COLLECTIVE AND UNITED BUSINESS ASSOCIATION.** (See exhibits for copies of support letters).

## **IX. CONFORMANCE WITH REDEVELOPMENT AREA PLAN**

The proposed project is in the **CICERO / STEVENSON** Tax Increment Financing Redevelopment Project Area. The proposed project will satisfy the following goals of the area's

redevelopment plan:

- Create a vibrant mixed-income community with both residential and commercial uses.
- Reactivate long-vacant land into a lively, active mixed-use development.

The implementation strategy for achieving the plan's goals envisions the need to provide TIF financial assistance for the development of MIXED-USE AFFORDABLE HOUSING. The proposed project also conforms to the plan's land use map, which calls for a MIXED-USE development at the subject site.

#### **X. CONDITIONS OF ASSISTANCE**

If the proposed resolution is approved by the CDC, DOH will negotiate a redevelopment agreement with the developer. The redevelopment agreement will incorporate the parameters of the proposed project as described in this staff report.

It is DOH policy that no business will be conducted with a development entity whose any principal has outstanding municipal debts (such as unpaid parking tickets, unpaid water bills, unpaid business licenses, and others), is in arrears of child support payments, or who is a debtor in bankruptcy, a defendant in a legal action for deficient performance, a respondent in an administrative action for deficient performance, or a defendant in any criminal action.

Closing of the sale of the property will not occur before the City Council has approved the redevelopment agreement, the developer has obtained all necessary City approvals including zoning and building permits, and the developer has presented proof of financing. The documents will include a development timetable.

#### **XI. RECOMMENDATION**

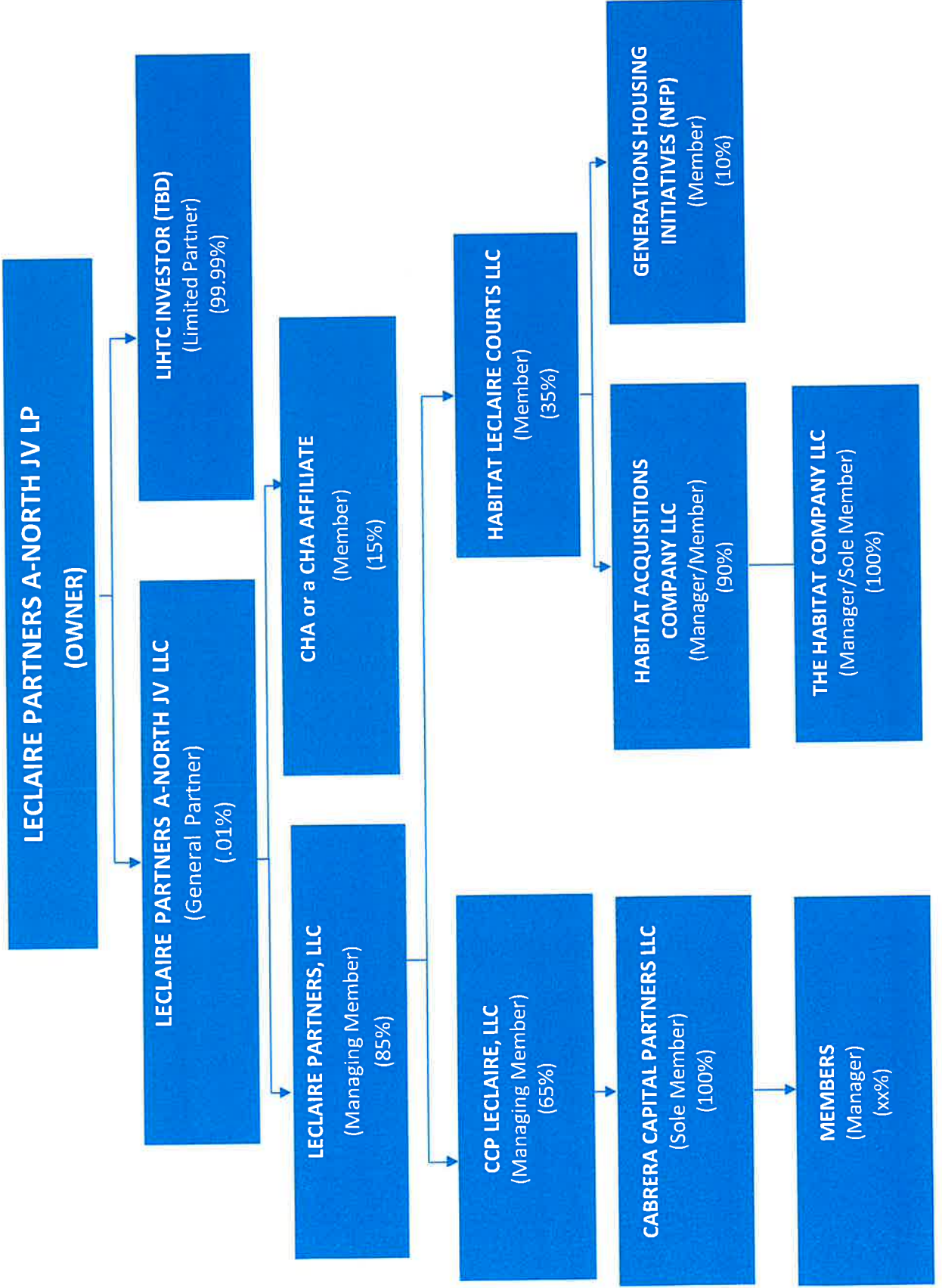

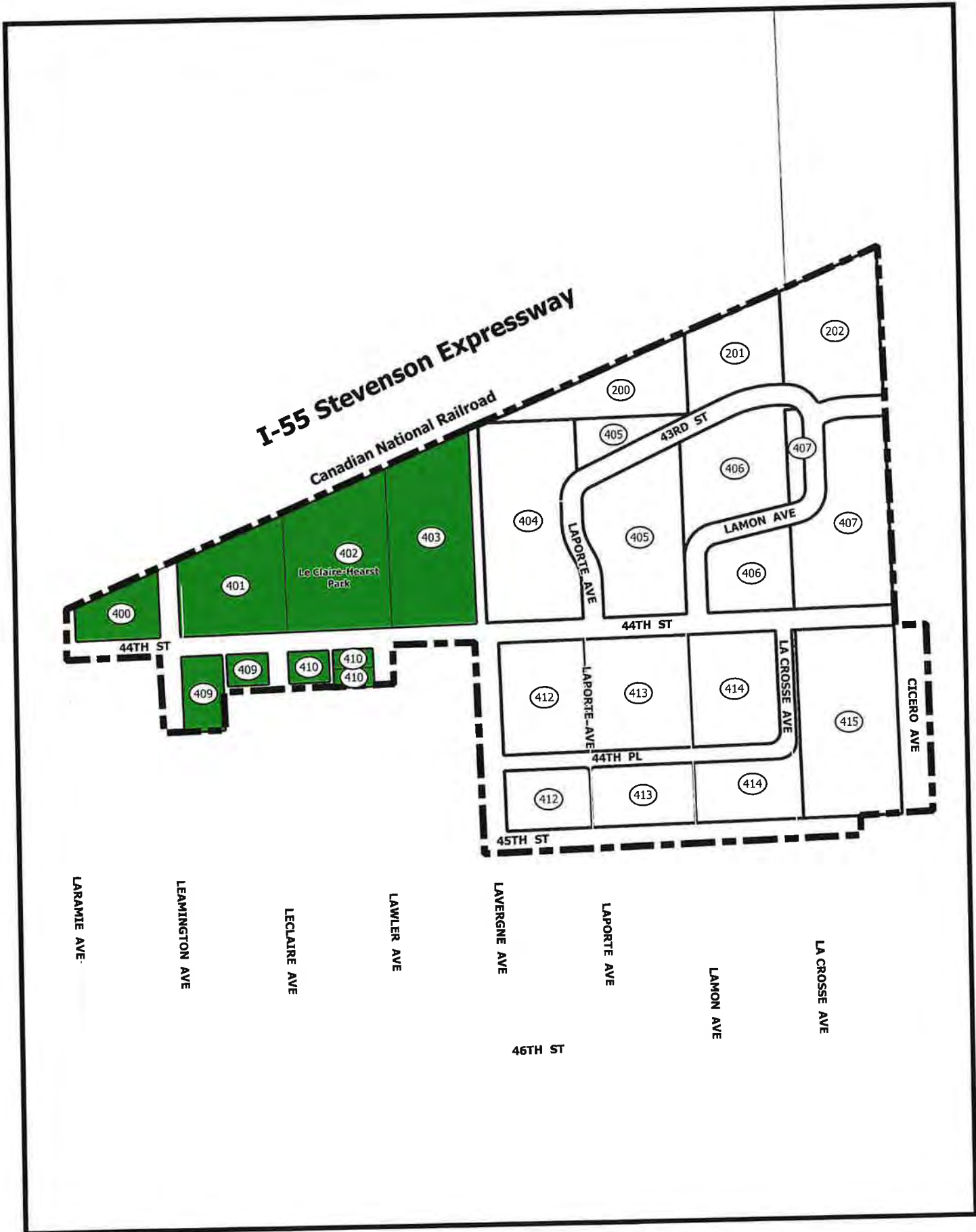




Figure 2. Project Area Boundary

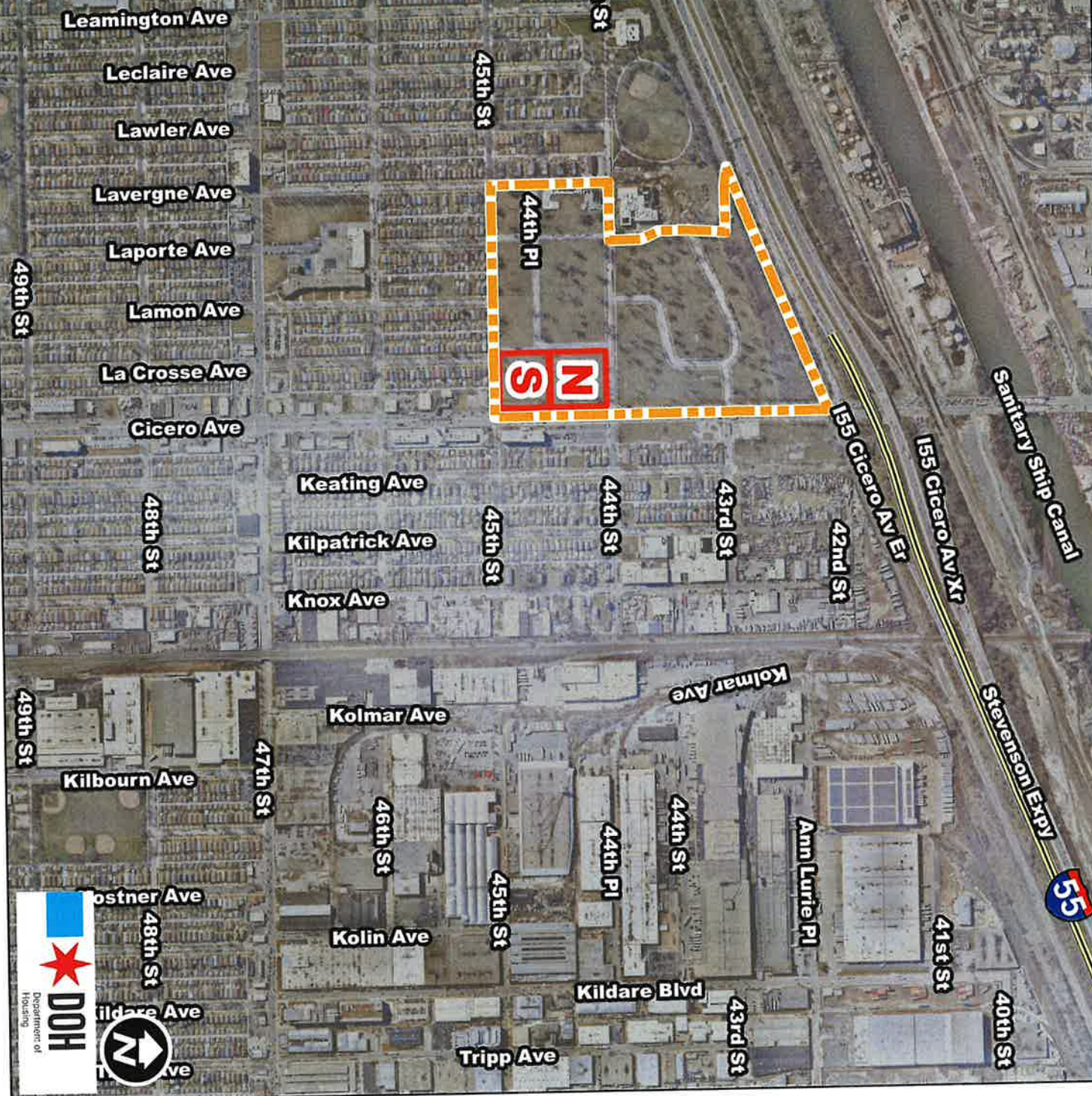

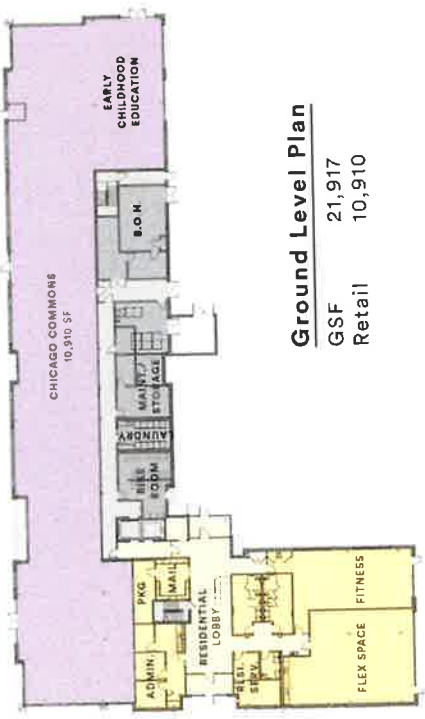

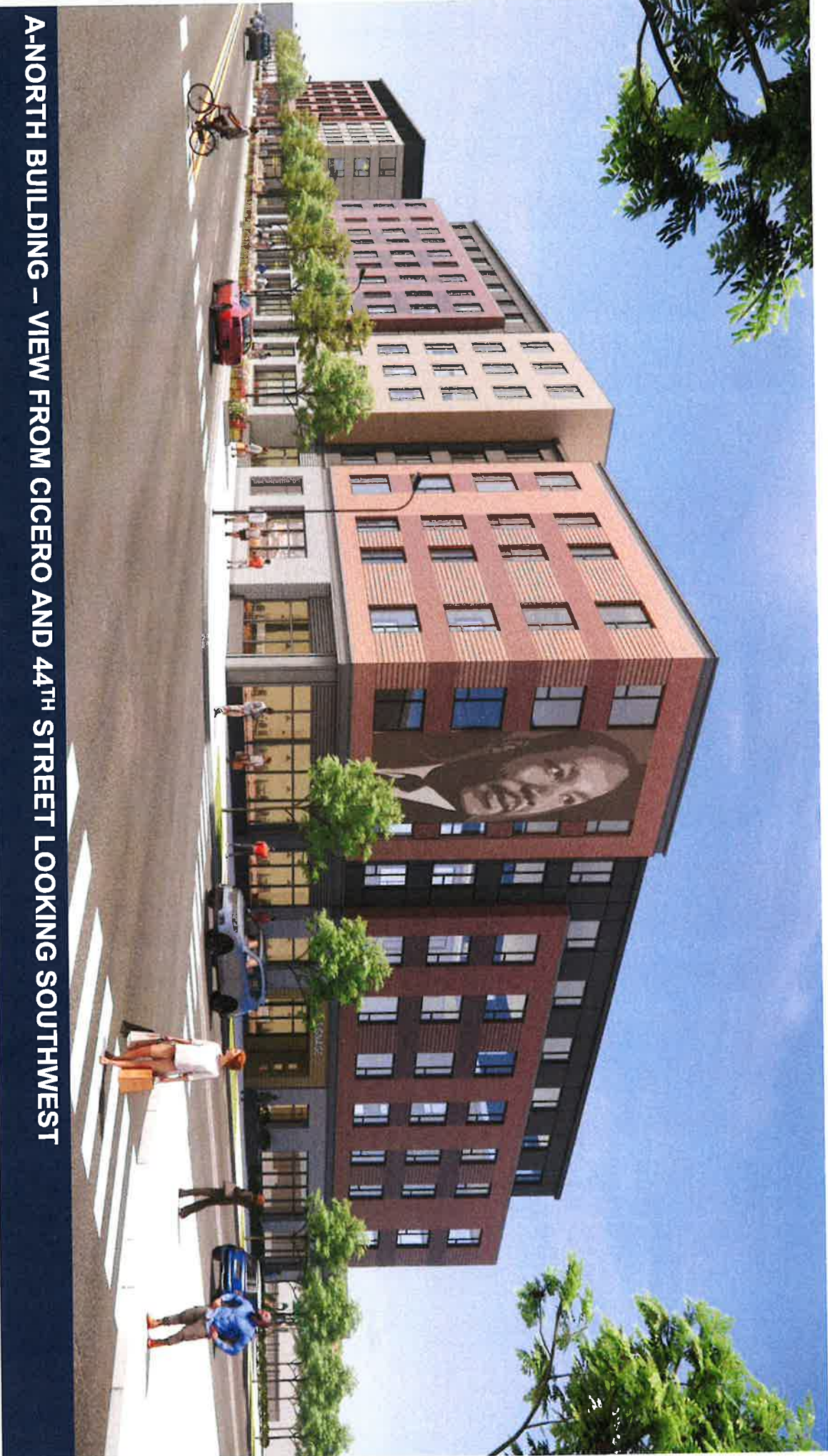

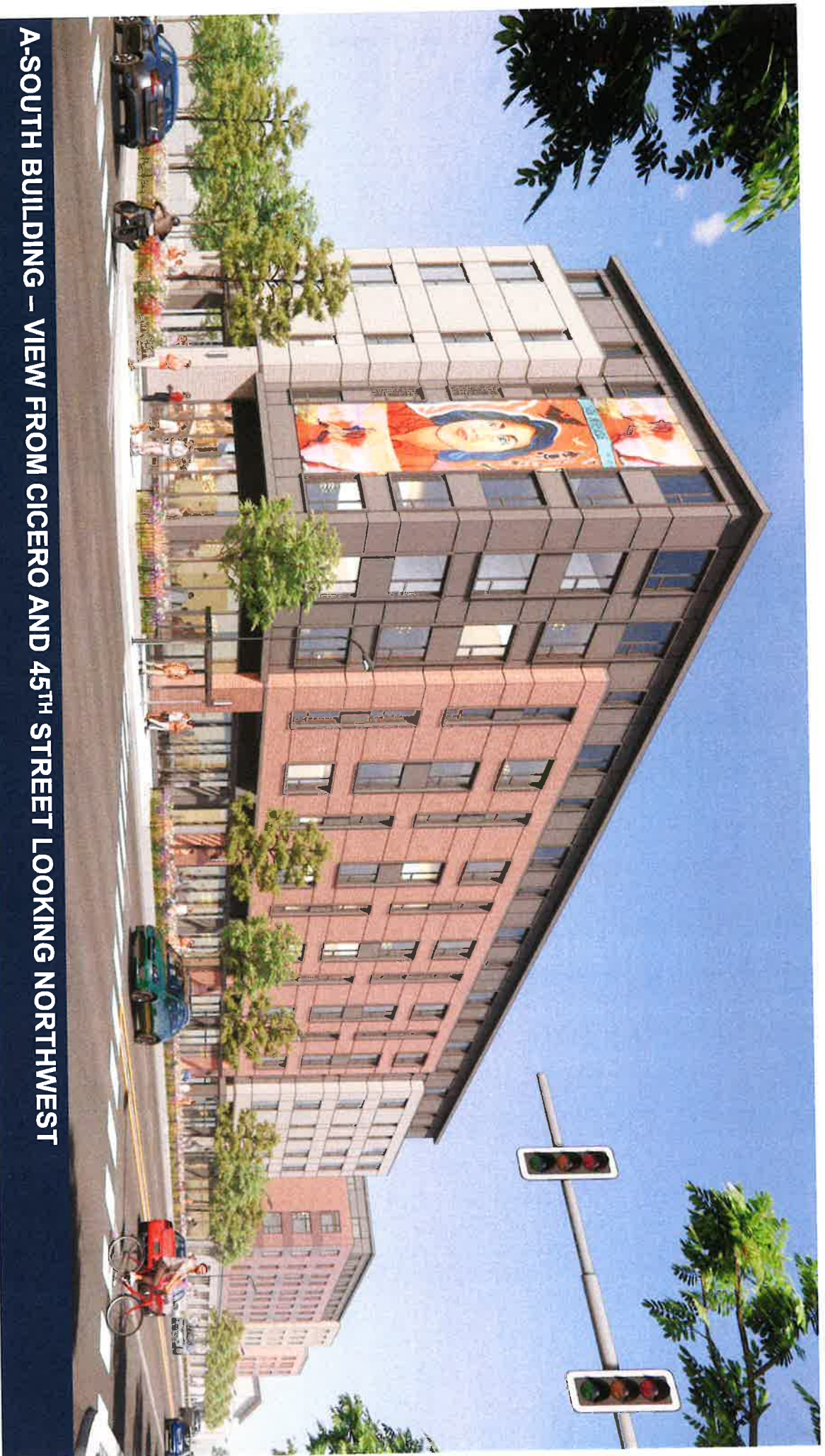

On behalf of The Southwest Collective, I am writing this letter in support of the first phase of the LeClaire Redevelopment Project, which is proposed to be built along Cicero Ave. between 43<sup>rd</sup> Street and 45<sup>th</sup> Street by the LeClaire Partners Development team.

Our organization strongly supports this project, which is part of a \$400 million redevelopment program that will transform this part of the Garfield Ridge community by delivering sorely needed affordable housing, retail and healthcare services. Over the past four years, we have met with LeClaire Partners to review the master plan for the former LeClaire Courts public housing development. The key partners in the development -- Cabrera Capital Partners, The Habitat Company, and the Chicago Housing Authority - have worked closely with the community in identifying the community's needs and priorities in developing the LeClaire redevelopment plan.

Quality affordable housing is in short supply on the Southwest Side of Chicago. The LeClaire redevelopment is the first large-scale affordable housing investment in this area. We are excited that the first phase of proposed housing at LeClaire A North and South buildings will include a total of 183 housing units, of which 90% will be designated as affordable for working families. We are also looking forward to commercial development on the adjacent site on Cicero between 43<sup>rd</sup> and 44<sup>th</sup> streets which will bring a sorely needed 90,000 sq. ft. grocery store, a federally qualified health center, and various shops and food options.

This commercial and housing development will breathe new life into an under-resourced part of the Midway corridor and create an anchor on the Southwest Side of Chicago. The redevelopment promises to deliver 700 construction jobs and 650 permanent jobs that will sustain the working families in this area for years to come and promises to be a catalyst for additional economic development in this corner of Chicago. It is exactly the kind of economic revitalization this community needs.
