WHEREAS, the Community Development Commission (the "Commission") of the City of Chicago (the "City") has heretofore been appointed by the Mayor of the City with the approval of its City Council (the City Council referred to herein collectively with the Mayor as the "Corporate Authorities") as codified in Section 2-124 of the City's Municipal Code; and

WHEREAS, the Commission is empowered by the Corporate Authorities to exercise certain powers enumerated in Section 5/11-74.4-4(k) of the Illinois Tax Increment Allocation Redevelopment Act, as amended (65 ILCS 5/11-74.4-1 et seq.), (as amended from time to time, the "Act"); and

WHEREAS, the City Council, upon the Commission's recommendation pursuant to Resolution 06-CDC-72 and pursuant to the Act, enacted three ordinances on November 15, 2006, and amended and corrected the ordinances on February 7, 2007 and May 9, 2007, pursuant to which the City approved and adopted a certain redevelopment plan and project (the "Plan") for the LaSalle Central Redevelopment Project Area (the "Area"), designated the Area as a redevelopment project area and adopted tax increment allocation financing for the Area. The street boundaries of the Area are described on Exhibit A hereto; and

WHEREAS, Field Building Revitalization Partners , LLC, together with its affiliates, (the "Developer"), has presented to the City's Department of Housing and Planning and Development (the "Departments") a proposal for redevelopment of the Area or a portion thereof that is in compliance with the Plan, consisting of the adaptive reuse of an existing office building to a 386-unit

residential development, including 116 (30%) affordable units and 92,000 square feet of commercial space (the “Project”); and

WHEREAS, The Departments request that the Commission recommend to City Council that the Developer be designated as the developer for the Project and that the Departments be authorized to negotiate, execute and deliver a redevelopment agreement with the Developer for the Project; now, therefore,

BE IT RESOLVED BY THE COMMUNITY DEVELOPMENT COMMISSION OF THE CITY OF CHICAGO:

- Section 1. The above recitals are incorporated herein and made a part hereof.
- Section 2. The Commission hereby recommends to City Council that the Developer be designated as the developer for the Project and that the Departments be authorized to negotiate, execute and deliver on the City’s behalf a redevelopment agreement with the Developer for the Project.
- Section 3. If any provision of this resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the remaining provisions of this resolution.
- Section 4. All resolutions, motions or orders in conflict with this resolution are hereby repealed to the extent of such conflict.
- Section 5. This resolution shall be effective as of the date of its adoption.
- Section 6. A certified copy of this resolution shall be transmitted to the City Council.

I. PROJECT IDENTIFICATION AND OVERVIEW

Proposed Project:	<p>The Development Team is proposing an adaptive reuse and conversion of approximately 624,000 square feet of the building to commercial and residential uses. On lower level one, the ground level, and level two, the project will feature 92,000 square feet dedicated to commercial space which is intended to include neighborhood amenities such as a small format grocer, health/fitness center, medical office, and complimentary uses. An approximate 100,000 square feet parking garage will be located on levels three and four for up to 177 cars. The residential component of the project consists of 430,050 square feet. Floors five through fourteen, will be converted into 386 residential units, of which 116 (30%) will be affordable to households with an average income of under 60% of the AMI. The residential units will also have access to both indoor and outdoor amenity space on floors five, 25, 43, and 44.</p>

Goal of Project:	Provide resources for the adaptive reuse of a functionally obsolescent office property into market rate and affordable residential housing and commercial use, the rehabilitation and modernization of existing structures, and restoration of a historically and architecturally significant building and its interior features.

II. PROPERTY DESCRIPTION

Address:	135 S. LaSalle Street
Location:	The project area is generally bounded by MARBLE PLACE on the north, CLARK STREET on the east, ADAMS STREET on the south, and LASALLE STREET on the west.

Current Use:	The property is a 1.35 million rentable square foot office property, of which approximately 83%, or 1.125 million rentable square feet, is vacant.

III. BACKGROUND

The LaSalle Street Reimagined initiative was launched on September 26, 2022, to address the lack of affordable housing options in the Loop and the unprecedented levels of office and retail vacancies, the rates of which are higher compared to the other Chicago downtown submarkets.

The initiative was motivated by post-pandemic economic conditions, including data that showed:

- 50% fewer workers in Chicago’s downtown, which was estimated to reduce spending downtown by \$3 billion per year
- 50% decline in downtown office building values, estimated to cause a \$1.1B reduction in the property tax base

The LaSalle Street Corridor includes a highly intact historic character (59% of the buildings are pre-1940) that is a 100% Transit Served Location.

However, it is an office monoculture, with 85% of the real estate allocated to office use, of which approximately 26% is vacant. Office vacancy has had a corresponding affect on the retail environment with approximately 30% of retail spaces in the central loop being vacant, both of which are higher than other downtown submarkets.

To address these issues, DPD initiated a six-month planning process in Q3 2020, during which one hundred fifty participants identified ninety action items, including the drafting of a Technical Assistance Panel by the Urban Land Institute on Repositioning LaSalle Street.

A market analysis completed in Q3 2022 identified a market for multi-unit residential, dining/entertainment and tourism/cultural uses along the LaSalle Street corridor and identified and evaluated fifteen underutilized office buildings for redevelopment.

Following these planning and data collection efforts, DPD issued an Invitation for Proposals on September 26, 2022, inviting proposals to convert office buildings to residential uses, with supporting retail/commercial uses.

The initiative uses public funding assistance to implement three interrelated components:

1. **Create affordable housing** - From nine applications submitted in December 2022, three finalists (111 W Monroe; 208 S LaSalle; 135 S LaSalle) were selected in March 2023, followed in May by two additional finalists (30 N LaSalle; 105 W Adams) and in January 2024 by an additional finalist (79 W Monroe).

On April 3, 2024, Mayor Johnson announced that four of these adaptive reuse projects would move forward for the City Council's consideration, including 111 W Monroe, 208 S LaSalle, 30 N LaSalle and 79 W Monroe. Since that announcement, the applicants for 135 S. LaSalle have revised their proposal and have been working with DPD and DOH, and the proposal was selected to move forward for City Council's consideration.

2. **Create an inviting and forward-thinking street:** Revitalization of LaSalle's streetscape and public realm with \$1M in initial funding for the engineering assessment and visioning work.
3. **Support locally owned cultural and dining businesses:** Up to \$5 million in Small Business Improvement Fund (SBIF) grants was approved by City Council in January 2023 for up to \$250,000 in grant funds for each awardee and an additional \$50,000 for businesses expanding from low- to medium-income communities. City assistance to support permanent improvements for seven restaurants, storefront and cultural enterprises are moving forward through the City's SBIF program. An additional SBIF funding round downtown opened in September 2024.

135 S. LaSalle

135 South LaSalle, known as the Field building, is a 44-story Art-Deco style building that was designed by Graham, Anderson, Probst, and White and was completed in 1934 and designated as a Chicago Landmark in 1994. The 1.35 million square foot building has large floor plates and has over

1.125 million square feet of vacancy (83%) mostly due to Bank of America’s headquarters relocating to 110 N. Wacker.

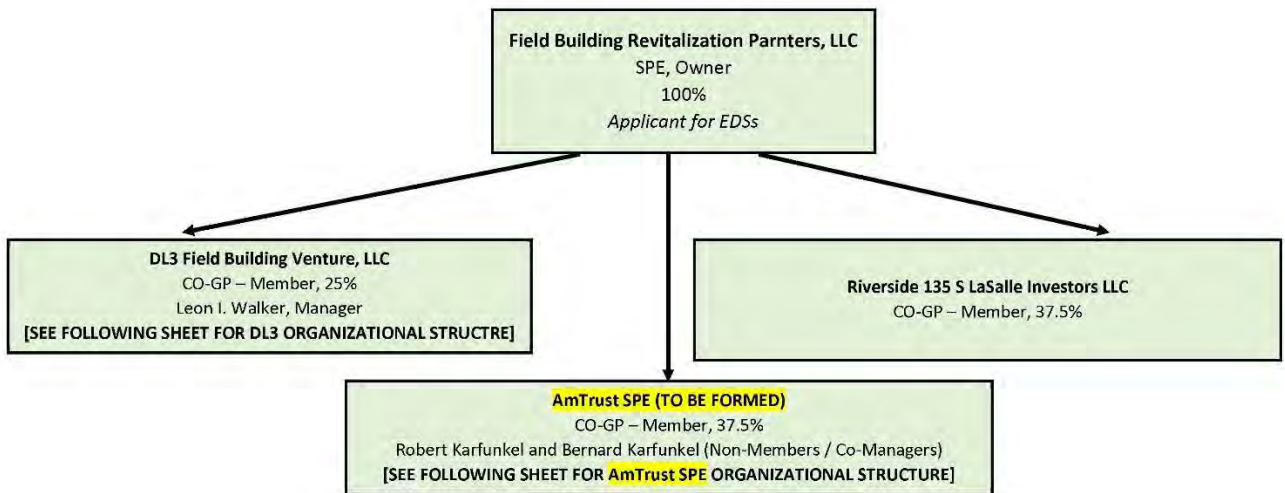
IV. PROPOSED DEVELOPMENT TEAM

Development Entity:

Field Building Revitalization Partners, LLC, a Single Purpose Entity, is the 100% owner, was created for this redevelopment. The Co-General Partners include Riverside 135 S LaSalle Investors LLC which has 37.5% interest, AmTrust SPE (to be formed) which has 37.5% interest, and DL3 Field Building Venture, LLC, which has 25% interest.

Experience: Riverside Investment & Development was founded in 2010 by John O'Donnell, who has over 40 years of local, national, and international real estate investment and development experience. Since 2016 Riverside has developed over 5 million square feet of projects representing over \$3 billion in capitalized transaction value. Local projects include 150 North Riverside (1.4 MSF), 110 North Wacker

AmTrust RE is a privately held firm that acquires, develops, and operates top-tier real estate across a variety of property types. The company currently owns and operates properties in several major U.S. markets with a significant concentration of holdings in Chicago and New York City. AmTrust RE and its professionals have significant experience in both ground-up and large-scale redevelopment projects in addition to building operations and asset management.

DL3 Realty is a local investment, development, and advisory firm committed to accelerating the transformation of emerging communities through high-impact commercial real estate projects. Local projects include mixed-income housing project Park Station, Washington Park Bank Building, and Thrive Exchange.

Architect: Solomon Cordwell Buenz (SCB) founded in 1931, is an architecture, interior design, and planning firm with a national presence. The firm has a strong history of adaptive re-use and renovation and multi-family development projects. SCB has designed multiple historic adaptive reuse projects in Chicago including the Tribune Tower, Beldon Stratford, and Lofts on Arthington.

General Contractor: For LaSalle Reimagined projects only, DOH's Construction and Compliance bureau has determined that developers may elect to work with one General Contractor (GC) with a demonstrated track record in aligning their construction costs with industry standards and in line with current costs of other downtown adaptive reuse projects. **However, the GC shall competitively bid for a minimum of three (3) subcontractors for the construction.** The developer has not selected a General Contractor yet.

V. PROPOSED PROJECT

Project Overview: This \$241 million adaptive reuse and conversion project will convert 361,350 square feet, located on levels five through 14, into 386 residential units, of which 116 (30%) will be affordable to households with an average income of under 60% of the AMI. The project will also feature residential amenities on levels five, 25, 43 and 44 that will include 46,700 square feet of indoor amenities and 24,000 square feet of outdoor amenities.

On lower level 1, the ground level, and level 2, the project will feature 92,000 square feet of commercial space which is intended to include neighborhood amenities such as a small format grocer, health/fitness center, medical office, and complimentary uses. A parking garage will be located on levels 3 and 4 for up to 177 cars.

Per-unit development cost is \$500,140. Annual operating costs start at \$8,000/unit.

Below are the combined residential and commercial sources for the overall project. A breakout of the residential and commercial budgets can be found in Section VI, Financial Structure.

Zoning: The Project is zoned DC-16. No zoning change is necessary.

Parking: The project is a transit-oriented development located near to the Quincy/Wells historic CTA station and numerous bus lines. Additionally, Union and LaSalle stations, Ogilvie station and Millennium Station are all within walking distance, providing train service to regional and national destinations.

A site plan, floor plans and elevation are provided as exhibits to this report.

Residential Unit Profile:

The following tables provide detailed descriptions of the market-rate and affordable components of the proposed project. The subject property will provide a total of **386** housing units of which **116** units or **30%** will be affordable for households earning no more than **80%** of the area median income. These units will satisfy the Chicago Affordable Requirements Ordinance, which requires 10% of the total units to be affordable in projects developed on land sold by the City or 20% of the units in projects receiving TIF assistance. The affordable units will have a 30-year affordable covenant both in the Redevelopment Agreement, or RDA, and in an Inclusionary Housing Agreement, or IHA.

*The price of each rental unit includes heat and water. Tenants pay for electric cooking and other electric (outlets, lighting, fans).

The affordable rent paid by the tenant is based on the tenant’s income, not on market comparables. The maximum rent for each defined “affordable” income level is published annually by the US Department of Housing and Urban Development and listed according to building construction type (i.e. apartment, townhouse, house), number of bedrooms and household size. Rent per square foot is not considered except that HUD housing quality standards and Chicago zoning and building codes set minimum room and unit sizes. Different federal funding development and operating support sources may have different maximum income and rent restrictions.

Environmental Features: The developer is proposing to meet the City’s sustainability requirements by seeking Green Globes certification which will include new energy efficient mechanical and electrical systems, LED lighting throughout, new insulated glass windows, green roof landscaping, Energy Star appliances, and indoor water reduction.

VI. FINANCIAL STRUCTURE

The project consists of mixed-income residential rental and commercial retail project that is funded with various sources of equity, public financing, and private financing. The residential component includes 386 residential units, of which 116 (30%) will be affordable to households with an average income of under 80% of the AMI and associated amenity spaces. The commercial component includes approximately 92,000 square feet dedicated to commercial space which is intended to include neighborhood amenities such as a small format grocer, health/fitness center, medical office, and spa. The project includes \$67,300,250 for residential and \$30,699,750 for commercial for a combined total of \$98 million in TIF assistance.

Residential Financial Structure:

In addition to the \$67,300,250 in TIF assistance, the residential portion will receive funds from the following sources:

1. 1st mortgage totaling \$86,000,000 (Lender TBD)
2. Owner equity of \$8,337,091
3. Historic Tax Credit equity of approximately \$25,896,798
4. Deferred Developer Fee of \$5,520,030

VII. PUBLIC BENEFITS

The proposed project will provide the following public benefits.

Affordable Housing: The project will provide **116** new affordable housing units.

Environmental Features: The developer is proposing to meet the City's sustainability requirements by new energy efficient mechanical and electrical systems, LED lighting throughout, new insulated glass windows, green roof landscaping, Energy Star appliances, and indoor water reduction.

Permanent Jobs: The project is estimated to generate **172** permanent jobs. The department's workforce development specialists will work with the developer on job training and placement.

Construction Jobs: The project will produce **893 TEMPORARY** construction jobs.

Affirmative Action: The developer will comply with the requirements of Chicago’s affirmative action ordinance, which requires contract participation of 26% by minority-owned business enterprises (MBEs) and 6% by woman-owned business enterprises (WBEs). The developer has provided notification of the proposed project, by certified mail, to several associations of minority and women contractors. A sample version of the letter and copies of the post office receipts for the certified letters are presented as exhibits to this report.

City Residency: The developer will comply with the requirements of Chicago’s city residency ordinance, which requires that at least half of all construction-worker hours be filled by Chicago residents. The developer will also comply with the requirement that all construction jobs are paid the prevailing wage.

VIII. COMMUNITY SUPPORT

Aldersperson **CONWAY** endorses the project and has provided a letter of support (see exhibits for copy). The project was presented to the community at a webinar meeting held on March 2, 2023. The following community organization(s) (has/have) endorsed the overall initiative: Chicago Loop Alliance, Building Owners and Managers Association, Preservation Chicago, and Landmarks Illinois.

IX. CONFORMANCE WITH REDEVELOPMENT AREA PLAN

The proposed project is in the **LASALLE CENTRAL** Tax Increment Financing Redevelopment Project Area. The proposed project will satisfy the following goals of the area’s redevelopment plan: Provide resources for the rehabilitation and modernization of existing structures, particularly historically and architecturally significant buildings. The implementation strategy for achieving the plan’s goals envisions the need to provide TIF financial assistance for the development of **REHABILITATION OF OFFICE TO RESIDENTIAL AND COMMERCIAL CONVERSION**. The proposed project also conforms to the plan’s land use map, which calls for **DOWNTOWN CORE MIXED-USE** development at the subject site.

X. CONDITIONS OF ASSISTANCE

If the proposed resolution is approved by the CDC, DPD will negotiate a redevelopment agreement with the developer. The redevelopment agreement will incorporate the parameters of the proposed project as described in this staff report.

It is DPD policy that no business will be conducted with a development entity whose any principal has outstanding municipal debts (such as unpaid parking tickets, unpaid water bills, unpaid business licenses, and others), is in arrears of child support payments, or who is a debtor in bankruptcy, a defendant in a legal action for deficient performance, a respondent in an administrative action for deficient performance, or a defendant in any criminal action.

Closing of the sale of the property will not occur before the City Council has approved the redevelopment agreement, the developer has obtained all necessary City approvals including zoning and building permits, and the developer has presented proof of financing. The documents will include a development timetable.

XI. RECOMMENDATION

The Department of Planning and Development has thoroughly reviewed the proposed project, the qualifications of the development team, the financial structure of the project, its need for public assistance, its public benefits, and the project's conformance with the redevelopment area plan, and DPD recommends that the CDC recommend to the City Council the designation of Field Building Revitalization Partners, LLC, or a related entity, as Developer for the development of converting office to residential at 135 South LaSalle Street.





Opinion

We have audited the accompanying financial statements of the LaSalle Central Redevelopment Project of the City of Chicago, Illinois, as of and for the year ended December 31, 2023, and the related notes to the financial statements, which collectively comprise the Project's basic financial statements as listed in the table of contents.

In our opinion, the financial statements referred to above present fairly, in all material respects, the respective financial position of the LaSalle Central Redevelopment Project of the City of Chicago, Illinois, as of December 31, 2023, and the respective changes in financial position for the year then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the City of Chicago, Illinois, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter

As described in Note 1, the financial statements of the LaSalle Central Redevelopment Project, City of Chicago, Illinois, are intended to present the financial position and the changes in financial position, of only that portion of the special revenue funds of the City of Chicago, Illinois that is attributable to the transactions of the LaSalle Central Redevelopment Project. They do not purport to, and do not, present the financial position of the City of Chicago, Illinois, as of December 31, 2023 and the changes in its financial position for the year then ended in accordance with accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America; and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.



Such information has been subjected to the auditing procedures applied in the audit of the basic financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the basic financial statements or to the basic financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. (UNAUDITED)

As management of the LaSalle Central Tax Increment Redevelopment Project Area (Project), we offer the readers of the Project's financial statements this narrative overview and analysis of the Project's financial performance for the year ended December 31, 2023. Please read it in conjunction with the Project's financial statements, which follow this section.

Overview of the Financial Statements

This discussion and analysis is intended to serve as an introduction to the Project's basic financial statements. The Project's basic financial statements include three components: 1) government-wide financial statements, 2) governmental fund financial statements, and 3) notes to the financial statements. This report also contains other supplementary information concerning the Project's expenditures by statutory code.

Basic Financial Statements

The basic financial statements include two kinds of financial statements that present different views of the Project – the *Government-Wide Financial Statements* and the *Governmental Fund Financial Statements*. These financial statements also include the notes to the financial statements that explain some of the information in the financial statements and provide more detail.

Government-Wide Financial Statements

The government-wide financial statements provide both long-term and short-term information about the Project's financial status and use accounting methods similar to those used by private-sector companies. The statement of net position includes all of the project's assets and liabilities. All of the current year's revenues and expenses are accounted for in the statement of activities regardless of when cash is received or paid. The two government-wide statements report the Project's net position and how they have changed. Net position – the difference between the Project's assets and liabilities – is one way to measure the Project's financial health, or position.

Governmental Fund Financial Statements

The governmental fund financial statements provide more detailed information about the Project's significant funds – not the Project as a whole. Governmental funds focus on: 1) how cash and other financial assets can readily be converted to cash flows and 2) the year-end balances that are available for spending. Consequently, the governmental fund statements provide a detailed short-term view that helps determine whether there are more financial resources that can be spent in the near future to finance the Project. Because this information does not encompass the additional long-term focus of the government-wide statements, we provide additional information at the bottom of the statements to explain the relationship (or differences) between them.

Notes to the Financial Statements

The notes provide additional information that is essential to a full understanding of the data provided in the government-wide and governmental fund financial statements. The notes to the financial statements follow the basic financial statements.

Other Supplementary Information

In addition to the basic financial statements and accompanying notes, this report also presents a schedule of expenditures by statutory code. This supplementary information follows the notes to the financial statements.

Condensed Comparative Financial Statements

The condensed comparative financial statements are presented on the following page.

Analysis of Overall Financial Position and Results of Operations

Property tax revenue for the Project was \$218,616,378 for the year. This was an increase of 28 percent over the prior year. The change in net position (including other financing uses) produced an increase in net position of \$43,802,330. The Project's net position increased by 12 percent from the prior year making available \$314,304,207 (net of surplus distribution) of funding to be provided for purposes of future redevelopment in the Project's designated area. Expenses increased this year due to the Project's formulation of a redevelopment plan or necessary funding was substantially complete and available.

NOTES TO FINANCIAL STATEMENTS

Note 1 – Summary of Significant Accounting Policies

(a) *Reporting Entity*

In November 2006, the City of Chicago (City) established the LaSalle Central Tax Increment Redevelopment Project Area (Project). The area has been established to finance improvements, leverage private investment and create and retain jobs. The Project is accounted for within the special revenue funds of the City.

The financial statements present only the activities of the LaSalle Central Tax Increment Redevelopment Project and do not purport to present the financial position and the changes in financial position of any other special revenue funds of the City of Chicago, Illinois, as of December 31, 2023 and for the year then ended in accordance with accounting principles generally accepted in the United States of America.

(b) *Accounting Policies*

The accounting policies of the Project are based upon accounting principles generally accepted in the United States of America as prescribed by the Governmental Accounting Standards Board (GASB).

(c) *Government-wide and Fund Financial Statements*

The government-wide financial statements (i.e., the statement of net position and the statement of activities) and the governmental fund financial statements (i.e., the balance sheet and the statement of governmental fund revenues, expenditures and changes in fund balance) report information on the Project. See Note 1(a).

(d) *Measurement Focus, Basis of Accounting and Financial Statements Presentation*

The government-wide financial statements are reported using the *economic resources measurement focus* and the *accrual basis of accounting*. Revenues are recorded when earned and expenses are recorded when a liability is incurred regardless of the timing of related cash flows. Property taxes are recognized as revenues in the year for which they are levied.

The governmental fund financial statements are reported using the *current financial resources measurement focus* and the *modified accrual basis of accounting* with only current assets and liabilities included on the balance sheet. Under *the modified accrual basis of accounting*, revenues are recorded when susceptible to accrual, i.e., both measurable and available to finance expenditures of the current period. Available means collectible within the current period or soon enough thereafter to be used to pay liabilities of the current period. Property taxes are susceptible to accrual and recognized as a receivable in the year levied. Revenue recognition is deferred unless the taxes are received within 60 days subsequent to year-end. Expenditures are recorded when the liability is incurred.

(d) *Measurement Focus, Basis of Accounting and Financial Statements Presentation (Concluded)*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results could differ from these estimates.

(e) *Assets, Liabilities and Net Position*

Cash and Investments

Cash being held by the City is generally deposited with the City Treasurer as required by the Municipal Code of Chicago. The City Comptroller issues warrants for authorized City expenditures which represent a claim for payment when presented to the City Treasurer. Payment for all City warrants clearing is made by checks drawn on the City's various operating bank accounts.

The City Treasurer and City Comptroller share responsibility for investing in authorized investments. Interest earned and fair market value adjustments on pooled investments are allocated to participating funds based on their average combined cash and investment balances. Since investment income is derived from pooled investments, the fair value measurement and fair value hierarchy disclosures of GASB 72 will not be separately presented in a note disclosure.

The City values its investments at fair value or amortized cost. U.S. Government securities purchased at a price other than par with a maturity of less than one year are recognized at amortized cost.

Deferred Inflows

Deferred inflows represent deferred property tax revenue amounts to be recognized as revenue in future years in the governmental fund financial statements.

Capital Assets

Capital assets are not capitalized in the governmental fund but, instead, are charged as current expenditures when purchased. The Government-wide financial statements (i.e., the statement of net position and the statement of activities) of the City includes the capital assets and related depreciation, if any, of the Project in which ownership of the capital asset will remain with the City (i.e., infrastructure, or municipal building). All other construction will be expensed in both the government-wide financial statements and the governmental fund as the City nor Project will retain the right of ownership.

(f) *Stewardship, Compliance and Accountability*

Illinois Tax Increment Redevelopment Allocation Act Compliance

The Project's expenditures include reimbursements for various eligible costs as described in subsection (q) of Section 11-74.4-3 of the Illinois Tax Increment Redevelopment Allocation Act and the Redevelopment Agreement relating specifically to the Project. Eligible costs include but are not limited to survey, property assembly, rehabilitation, public infrastructure, financing and relocation costs.

The maximum reimbursable amount is set forth in each agreement. If the total project cost is lower than the project budget established in the agreement, the reimbursable amount will be prorated.

Note 2 – Surplus Distribution

In December 2022, the City declared a surplus within the fund balance of the Project in the amount of \$155,071,461. In March 2023, the surplus funds were sent to the Cook County Treasurer's Office to be redistributed to the various taxing agencies.

In December 2023, the City declared a surplus within the fund balance of the Project in the amount of \$95,793,442. In April 2024, the surplus funds were sent to the Cook County Treasurer's Office to be redistributed to the various taxing agencies.

Note 3 – Tax Abatement Agreement

GASB Statement No. 77, Tax Abatement Disclosures ("GASB 77"), requires governments that enter into tax abatement agreements to disclose: (1) brief descriptive information concerning the agreement; (2) the gross dollar amount of taxes abated during the period; and (3) commitments made by government, other than to abate taxes, that are part of the tax abatement agreement.

The City uses tax increment financing to pay for (or reimburse) developers for the costs of the TIF-funded improvements pursuant to the terms and conditions of the redevelopment agreement entered into by the City and the developer.

Under the terms of a redevelopment agreement, the Project paid a developer \$22,231,836 during the year ended December 31, 2023.

Note 4 – Commitments

As of December 31, 2023, the Project has various outstanding service and construction projects with encumbrances for approximately \$960,959.

In connection with our audit, nothing came to our attention that caused us to believe that the Project failed to comply with the regulatory provisions in Subsection (q) of Section 11-74.4-3 of the Illinois Tax Increment Allocation Redevelopment Act and Subsection (o) of Section 11-74.6-10 of the Illinois Industrial Jobs Recovery Law as they relate to the eligibility for costs incurred incidental to the implementation of the LaSalle Central Redevelopment Project of the City of Chicago, Illinois.

However, our audit was not directed primarily toward obtaining knowledge of such noncompliance. Accordingly, had we performed additional procedures, other matters may have come to our attention regarding the Project's noncompliance with the above referenced regulatory provisions, insofar as they relate to accounting matters.

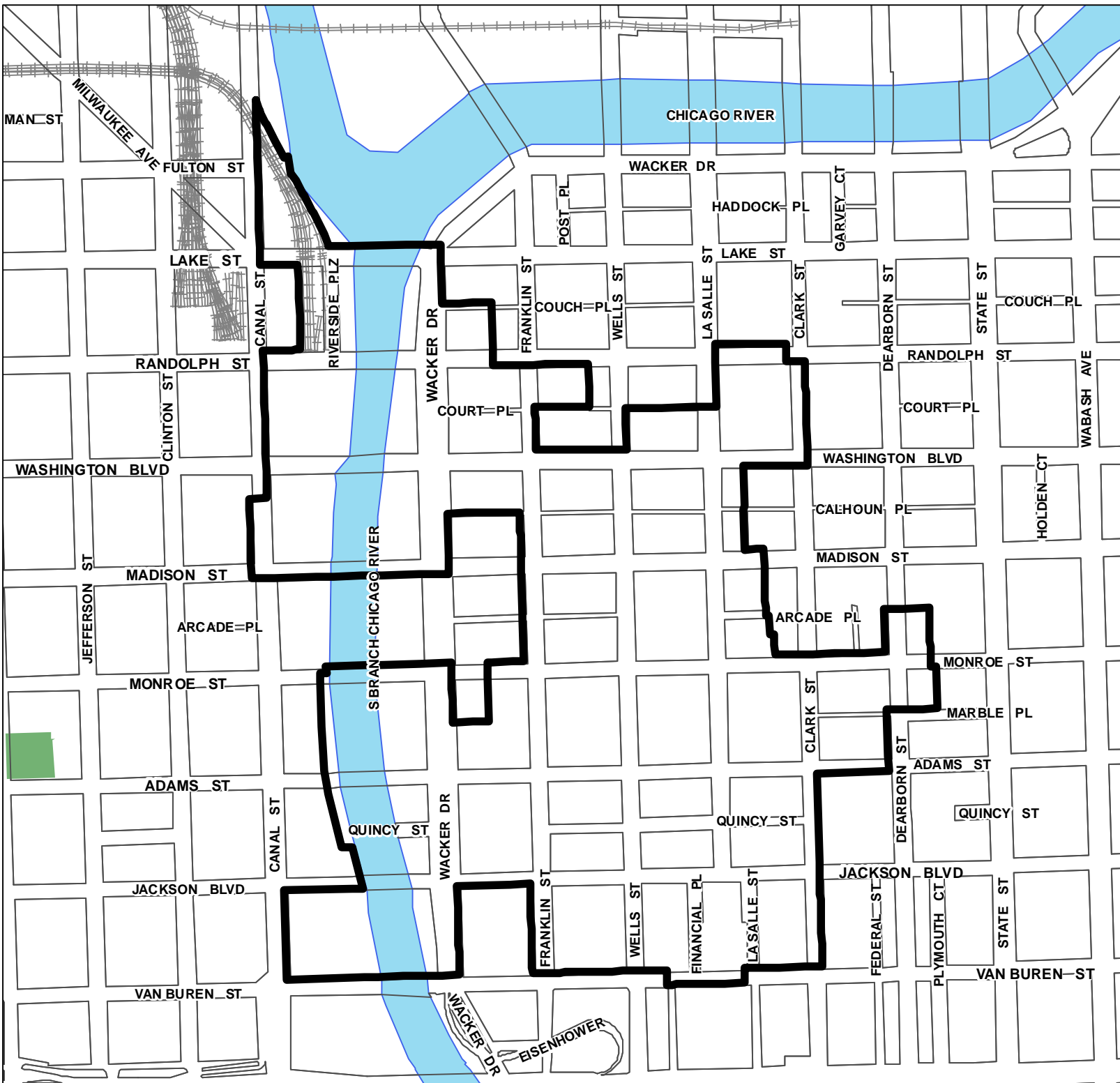

Preservation Chicago strongly supports the advancement of the 135 S. LaSalle adaptive reuse project to City Council for their consideration and approval. This important project will convert vacant office floors into 386 residential units of which 30% or 116 units will be affordable to households with an average income of 60% AMI, and provide neighborhood serving retail uses that may include a small format grocer and a health/fitness center, which will help address the lack of affordable housing units and the unprecedented levels of office and retail vacancies in the Loop.

The Art Deco-style building, known as the Field Building, was designed by Graham, Anderson, Probst, and White and completed in 1934. The property was designated as a Chicago Landmark in 1994. The building has over 1.125 million square feet (83%) of vacant rentable space and the proposal will convert 10 floors or 350,000 square feet of vacant office space into residential uses, 43,000 square feet into indoor and outdoor amenity uses, and 92,000 square feet into retail uses.

The development team includes Riverside Investment & Development, AmTrust RE, and DL3 Realty. As of the date of this letter, the 135 S. LaSalle project anticipates utilizing up to \$98 million in TIF funds and \$32 million in Federal Historic Rehabilitation Tax Credits. The total cost of the project is estimated at \$241 million.

Preservation Chicago fully supports providing public financial assistance to support this adaptive reuse project. Leveraging this historic building in order to bring additional residents to the Loop is critical to revitalizing downtown into an inclusive and vibrant live, work, play and dine neighborhood.

I strongly support the advancement of the 135 S. LaSalle Street adaptive reuse project to City Council for their consideration and approval. This important project will convert vacant office floors into 386 residential units of which 116 units (30%) will be affordable to households with an average income of 60% AMI. This project will also provide neighborhood retail uses, and will help address the lack of affordable housing units and the unprecedented levels of office and retail vacancies in the Loop.

The building has over 1.125 million square feet (83%) of vacant rentable space and the proposal will convert 350,000 square feet of vacant office space on 10 floors into residential units, 43,000 square feet into indoor and outdoor amenity uses, and 92,000 square feet into retail space.

The development team includes Riverside Investment & Development, AmTrust RE, and DL3 Realty. As of the date of this letter, the 135 S. LaSalle Street project anticipates utilizing up to \$98 million in TIF funds and \$32 million in Federal Historic Rehabilitation Tax Credits. The total cost of the project is estimated at \$241 million.
