NOVA MOBILITY SOLUTIONS**

PROCUREMENT HISTORY

In January of 1997, the Chicago Police Department (CPD) and Chicago Fire Department (CFD) purchased approximately 1,700 portable data terminal (PDT) from MicroSlate. These data terminals are linked to communication dispatch consoles at the Office of Emergency Management and Communication (OEMC). In addition to dispatch, OEMC is also responsible for the purchase and maintenance of the PDTs. Given that the PDTs are used 24 hours a day, 365 days per year a significant amount of maintenance and repair is required.

At the time of the original purchase MicroSlate was the sole manufacturer of this product. Additionally, given the difficulty in finding electrical mechanics that have the training and experience to perform maintenance and repair, many of the PDTs were maintained and supported by MicroSlate directly.

OEMC recently pursued a contract extension with MicroSlate, but that company has since declared bankruptcy. Bankruptcy proceedings indicated that Nova Mobility Solutions has taken possession of the MicroSlate parts inventory and the license to manufacture the unique components and assemblies used by the PDT. Because these PDT parts were unique to MicroSlate (and now Nova Mobility Solutions), OEMC cannot use other vendors.

The Sole Source Board recognized the uniqueness of this product by approving the original contract in 1998 and re-approving another in 2005. Over \$10 Million has been invested in the MicroSlate/Nova PDT technology. While OEMC plans a multi-year transition to newer technology through more sound companies, the existing PDTs must be maintained to support Police in the field. Maintenance and repair require long lead-time; in certain repair situations parts can take weeks to several months to be ordered and delivered. To address the large backlog of downed PDTs, a new sole source contract is required to overcome delays due to unexpected supplier bankruptcy.

ESTIMATED COSTS

The cost based on the attached price list from Nova Mobility Solutions and based on the number of PDTs that need repair is \$833,000 per year. OEMC is requesting a three year contract for a total of \$2,500,000.

SCHEDULE REQUIREMENTS

Maintenance and repair requires long lead-time; for example, in certain repair situations parts can take up to twenty-eight weeks to be ordered and installed. At any given time there are approximately 200-300 PDTs that need to be serviced and repaired, which is a direct result of heavy field use. Currently, however, OEMC requires spare and replacement parts for 2,800 existing PDTs used by the Chicago Police Department.

This is a request for a new three-year contract, with two one-year extension options, with a ceiling of \$2,500,000. It is imperative that a new service contract be put in place, as PDTs are important public safety equipment.

EXCLUSIVE OR UNIQUE CAPABILITY

Nova Mobility Solutions is the only vendor that currently can provide parts for the Police Department's PDTs, which were developed and manufactured by MicroSlate prior to that company declaring bankruptcy. Following the bankruptcy distribution of assets, no other vendor besides Nova Mobility Solutions has access to MicroSlate's inventory. Accordingly, it is not possible for the City to use any other vendor with an active city contract or to issue a competitive bid for this commodity.

Nova Mobility Scope of Services

Purpose:

The Office of Emergency Management and Communications (OEMC) maintains the PDTs (portable data terminals) used by all Chicago Police Department field personnel in official vehicles. These laptop computers are used by Police officers to communicate with and receive dispatches from the 9-1-1 Center and the Police Department.

The purpose of this letter is to explain why Nova Mobility Solutions, Inc. should be appropriately considered as the sole source supplier for the City of Chicago for its spare parts requirements for its Microslate 3000PIII computers.

Microslate Inc. was a Canadian company that specialized in the design and manufacture of rugged computers. The units currently in use by the City of Chicago police department were designed by Microslate and its engineers. The components in use in those systems are based upon proprietary designs of Microslate and are acquired from suppliers that manufacture those components to Microslate specifications.

In November 2005, Microslate, Inc. was declared bankrupt. All of the assets of Microslate, including its patents, trademarks, copyrights, and proprietary designs were awarded to the secured creditor of Microslate, Channel Analytics Inc. Subsequent to that award, Nova Mobility Solutions acquired those same assets from Channel and restarted the business of Microslate. Attached for your review are a copy of the award of the Canadian bankruptcy Trustee and a letter from Channel Analytics confirming the sale of those assets to Nova Mobility Solutions, Inc.

Nova is now the sole owner of Microslate's inventory and manufacturing rights. Many of the required components are manufactured using molds and dies that only we possess. The various electrical components are manufactured according to proprietary designs of Microslate by suppliers that are exclusive to Microslate and now Nova.

I trust that this information is considered appropriate justification for the application for sole source supply by Nova. Should you require any further information, please contact me directly.

DEMERS BEAULNE LACHANCE INC., Trustee to the bankruptcy estate of Microslate Inc., having its registered office at 1100 René-Lévesque Boulevard West, Suite 2010, Montreal, Province of Quebec H3B 4N4 (hereinafter the "Trustee");

and

CHANNEL ANALYTICS LTD., a company duly incorporated under the laws of the state of Delaware, having its registered office at 370 Reed Road, Suite 329, Broomall, PA, 19008 (hereinafter the "Assignee");

WHEREAS under the terms of a loan agreement entered into on October 29, 2004, (the "Loan Agreement"), **LES ANALYSES CHANNEL LTÉE / CHANNEL ANALYTICS LTD.**, a company duly incorporated under the laws of the Province of Quebec, having its registered office at 1155, René-Lévesque Blvd. West, Suite 2701, Montreal, Province of Quebec, H3B 2K8, (hereinafter the "Secured Creditor" or "Lender") lent the Debtor the sum of US\$500,000.00 and the Debtor acknowledged owing and promised to pay to the Secured Creditor the sum of US\$500,000.00 (the "Capital Amount") on December 31, 2005 (the "Maturity Date") together with interest on the unpaid portion of the Capital Amount at a yearly rate of eighteen percent (18%), payable monthly at a rate of one and a half percent (1.5%) per month starting November 1, 2004 (the "Interests").

WHEREAS the payment of the Capital Amount and the Interests (together referred to as the "Indebtedness") was secured by a movable hypothec granted by the Debtor to the Secured Creditor on October 29, 2004 and registered at the *Registre des droits personnels et réels mobiliers* ("RDPRM") on November 18, 2004, under number 04-0667537-0002 (the "Hypothec").

WHEREAS the property charged by the Hypothec (the "Charged Property") consists of the universality of all of the Grantor's movable property, present and future, corporeal and incorporeal, of whatsoever nature or kind and wherever situated, including without limitation:

1.1 Inventory

The universality of property consisting of:

All inventory of every nature and kind of the Grantor whether in its possession, in transit or held on its behalf, including raw materials, work in process, finished goods (whether manufactured or transformed by the Grantor or by others), all packaging materials, all property of the Grantor held, possessed or detained by a third party under a lease, loan, deposit, license, franchise, or other agreement entered into with or on behalf of the Grantor, all property evidenced by bill of lading, all mineral substances, hydrocarbons and other products of the soil, as well as all fruits thereof from the time of their extraction, and all other similar property, whether corporeal or incorporeal (hereinafter called the "Inventory").

Property forming part of the Inventory which is conditionally alienated by the Grantor (for example, by way of an installment or conditional sales contract) shall remain charged with the Hypothec until title is transferred to the acquirer. If the ownership of any Inventory reverts to the Grantor pursuant to the resolution or rescission of any agreement or otherwise it shall also be subject to the Hypothec.

1.2 Claims and Other Movable Property

The universality of property consisting of:

(a) Claims

All of the Grantor's claims of every nature and kind, whether or not such claims: A) are certain, liquid or exigible; B) are litigious; C) have previously been or are to be invoiced; D) constitute book debts; or E) are evidenced by any title, bill of exchange or draft, negotiable or otherwise; and specifically including: (i) indemnities payable to the Grantor under any contract of insurance of property, of persons, or of liability insurance, subject to the rights of creditors holding hypothecs on the insured

property, if any, and (ii) the Grantor's rights in the credit balance of accounts held for its benefit either by the Holders (subject to the Holders's compensation rights) or by any financial institution or other person;

(b) Contract Rights and Rights of Action

All of the Grantor's rights under contracts with third parties as well as all of the Grantor's rights of action against third persons;

(c) Accessories

The hypothecs, security, suretyships and accessories to the claims and rights described above and other rights relating thereto (including, without limitation, the rights of the Grantor in its capacity as seller of any property, whether inventory or not, under an installment or conditional sale, where the claims are the result of such sale);

(hereinafter collectively called the "Claims" and individually a "Claim"). No right or Claim shall be excluded from the Charged Property merely because: (i) the debtor thereof is domiciled outside the Province of Quebec; or (ii) the debtor thereof is an affiliate (as such term is defined in the Canada Business Corporations Act) of the Grantor (regardless of the law of the jurisdiction of its incorporation); or (iii) where the Grantor is not a natural person, such right or Claim is not related to the operation of an enterprise.

1.3 Intellectual Property and Rights

The universality of property consisting of all intellectual property rights of every nature whatsoever, including without limitation all copyrights, trademarks, trade names and patents, whether or not registered, including the intellectual property, if any, described in Schedule "A".

1.4 Securities

The universality of property consisting of all securities (including without limitation shares, options, rights, warrants, derivative products such as swap agreements, foreign exchange futures contracts and others (to the extent not already charged under subsection 1.2(b)), units, bonds and similar instruments and any instrument which would constitute a "security" within the meaning of the Securities Act of Quebec) issued or to be issued in favour of the Grantor (the "Securities"), including without limitation the Securities issued or to be issued by the corporations, partnerships and other entities, if any, listed in Schedule "A".

1.5 Equipment and Road Vehicles

The universality of equipment, office furniture, tools, machinery, rolling stock (including road vehicles) (the "Equipment"), including without limitation the Equipment, if any, described in Schedule "A".

1.6 Non-Inventory Installment or Conditional Sales

The universality of all movable property not constituting inventory which is owned by the Grantor and contemplated by an installment or conditional sale referred to in subsection 1.2(c) hereof.

1.7 Other Property

The other movable property of the Grantor described in Schedule "A" under the heading "Other Property", which property forms part of the universality described in this Section 1.7.

1.8 Accessories, Proceeds, Reinvestment, Repurchase

The universality of property consisting of the proceeds, fruits and revenues of the Charged Property, including (by way of example and without limitation) trade-ins, equipment, cash, bank accounts, notes, negotiable instruments, bills, commercial paper, Securities, monies, goods, contract rights, compensation for expropriation and any other movable property, corporeal or incorporeal, received when any Charged Property is sold, exchanged, collected or otherwise disposed of.

In any case in which the Charged Property includes a universality, any Charged Property which is acquired, transformed or manufactured after the date of this Agreement shall be charged by the Hypothec, whether or not:

- (a) such Charged Property has been acquired in replacement of other Charged Property which may have been alienated by the Grantor in the ordinary course of business; or
- (b) such property results from a transformation, mixture or combination of any Charged Property; or
- (c) in the case of Securities, they have been issued pursuant to a purchase, redemption, conversion, cancellation or any other transformation of the Securities originally comprised in the Charged Property;

and without the Holders being required to register or re-register any notice whatsoever, the object of the Hypothec being a universality of present and future property.

WHEREAS all rights of the Secured Creditor, under the Loan Agreement and the Hypothec, were assigned to the Assignee;

WHEREAS the Debtor has defaulted and failed to fulfill its obligations under both the Loan Agreement and the Hypothec;

WHEREAS on November 22, 2005, the Assignee served upon the Debtor a prior notice of exercise of its hypothecary right of taking the Charged Property in payment of the Indebtedness, which prior notice was registered on November 23, 2005, at the RDPRM, under number 05-0665594-0002;

WHEREAS on November 29, 2005, the Debtor was declared bankrupt and Demers Beaulne Lachance Inc. was appointed trustee to the estate of the Debtor;

WHEREAS the prescribed 20 days to remedy the default is expired and the Debtor has not paid, nor has any other interested person, the Indebtedness owed to the Assignee, nor has anyone cured the omissions or breaches set forth in the prior notice and, moreover, no notice under 2779 C.C.Q. was registered;

WHEREAS the Debtor has not already discharged one-half or more of the Indebtedness secured by the Hypothec;

WHEREAS the Trustee has been authorized to enter into this Deed and to voluntarily surrender the Charged Property to the Assignee, by resolution of the board of the inspectors to the bankruptcy of Microslate Inc., dated this December 23, 2005;

NOW THEREFORE THIS DEED WITNESSES THAT:

The Debtor, herein represented by Demers Beaulne Lachance Inc., its trustee in bankruptcy, and the Trustee who presently has possession of the Charged Property, hereby voluntarily surrenders the Charged Property;

The present deed of voluntary surrender shall constitute, in favor of the Assignee, its title of ownership over the Charged Property and the taking in payment of said Charged Property extinguishes the Indebtedness of the Debtor secured by the Hypothec;






