



Deep Excavation/Foundation Professional Engineering Services

* Upcoming Contract: **Deep Excavation/Foundation Reviews and Field Inspections**

Scope of Project: Awarded vendor shall perform Professional Engineering Services for the reviews of private and public projects which have excavations and/or penetrations equal to or greater than 12 feet below existing grade within the limits of the City of Chicago and within the criteria outlined in the CDOT-DIM Geotechnical Review Guidelines. The Contractor shall be responsible for the professional and technical review of all plans, designs, drawings, specifications, procedures, calculations, methods and designs by others, attending meetings, providing comprehensive written review comments, and all other work or materials furnished for the Contract.

The Contractor shall be responsible for construction site field inspections for compliance with Deep Excavation/Foundation projects that have been approved for construction. Construction site field inspections shall also include the contractor to document and to monitor damage or potential damage of the City's right-of-way (ROW) during construction. The Contractor shall also be responsible for reviewing damage monitoring compliance set forth by the City for Deep Excavation/Foundation projects.

This Contract takes effect as of the effective date and continues for **60 months**, unless terminated earlier pursuant to the Termination provision, or extended according to the terms of the Contract Extension Option provision.
