Good morning, All:

Looking forward to continuing to build the partnership with Chicago Police Department (CPD) and Los Angeles Police Department (LAPD) through Peer Exchange and building out a Community Safety Partnership (CSP).

LAPD has requested that no visit occurs in December, as their calendars are too full with events and time off requests for holidays and vacations.
