**BOARD FINDS LOBBYISTS IN VIOLATION OF LAW FOR FAILING TO RE-REGISTER OR
TERMINATE, OR FILE 4TH QUARTER ACTIVITY REPORTS AS REQUIRED BY LAW,
ASSESSES FINES**

Pursuant to §§2-156-465(b)(3) and -505 of the Governmental Ethics Ordinance, the following registered lobbyists were determined to have violated their lobbyist filing requirements, as set forth in §§2-156-230, -245, or -270, and -505, by failing to re-register or terminate their registration as required by law (indicated with no asterisk), or to file their 4th Quarter activity reports as required by law (indicated with an asterisk *).

They will be assessed fines of \$250 for each day they are not in compliance, beginning February 27, 2025.
