If emergency housing is needed, or if you need rental assistance call 311, and ask for “short-term rental assistance. Experiencing homelessness visit one of the Chicago Community Centers and ask to speak with someone in the Department of Family and Support Services to be referred to a shelter and to be accessed for Permanent Supportive Housing. If you are Housed but concerned that you may lose your housing, please call the Homeless Prevention Call Center at 311 and tell the operator you “need short-term help.” Visit or contact one of the City’s service centers, if you or someone you know needs help with food and clothing, Domestic Violence Assistance, Job Training/Placement, Prisoner re-entry, rental, utility, and other financial assistance programs.
