What is the fine range for performing construction work outside of allowed hours?

Answer:

Construction work outside between 8:00 p.m. and 8:00 a.m. is not entirely prohibited. What is prohibited is the use of electrical or gas powered mechanical equipment or tools between the hours of 8:00 p.m. and 8:00 a.m. The applicable Code section is 8-32-140 (below) which has its own fines provision.

8-32-140 Construction, repair or demolition equipment.

(a) No person shall use or cause the use of any mechanical equipment or tool operated by fuel or electric power in building, construction, repair or demolition operations between the hours of 8:00 P.M. and 8:00 A.M. within 600 feet of any residential building or hospital.

(b) The limitation of this section does not apply to any construction, demolition or repair work of an emergency nature or to work on public improvements authorized by a governmental body or agency.

(c) This section may be enforced by designated employees of the departments of police, buildings, business affairs and consumer protection, fire, finance, streets and sanitation, transportation and planning and development, who are authorized to issue citations for violations.

(d) Any person who violates this section shall be liable for a penalty of not less than \$1,000.00 nor more than \$2,500.00 for the first violation; not less than \$2,500.00 nor more than \$5,000.00 for the second violation for the same offense within one year; and not less than \$5,000.00 nor more than \$10,000.00 for the third and each subsequent violation for the same offense within one year for each offense. Each day that a violation continues shall constitute a separate and distinct offense.

What is the fine range for performing work without a permit?

Answer:

The fine range for work without a permit is covered in section 13-12-050 (below) of the Code which has its own fines provision.

In addition to the fines in section 13-12-050, the City may also issue a Stop Work Order pursuant to section 13-12-080 (below) of the Code.

In addition to the fines in section 13-12-050, if a Stop Work Order is issued the person must also obtain a permit and pay an extra permit fee, the minimum of which is 100% of the permit fee, and a penalty of \$1,000 pursuant to section 13-32-035 (below).

As an example: A basic permit to build a deck is \$300.

The total potential minimum fine and penalties for building a deck without permit that also resulted in a Stop Work Order would be \$1,500 plus the \$ 300 permit fee.

\$ 200 fine (13-12-050(A)(3))

\$ 300 permit fee penalty (100% of permit fee) (13-32-035(a)(1))

\$1,000 Stop Work Order penalty (13-22-035(b))

The same penalties can be applied for work contrary to approved plans or beyond the scope of a permit pursuant to section 13-32-120 (below).

13-12-050 Construction, alteration, installation, repair or razing without permit – Penalty.

A. It shall be unlawful for any person to:

(i) construct, alter, install, repair or raze any building, structure, premises or part thereof without having obtained any permit required by this Code; or

(ii) construct, alter, install, repair or raze any building, structure, premises or part thereof in a manner which is contrary to the drawings or plans which the appropriate department or city agencies approved when issuing any permit required by this Code; or

(iii) maintain or operate any building, structure, premises, mechanical installation, equipment or part thereof without any permit or certificate required by this Code.

Any person who violates this subsection upon conviction shall be punished, as follows:

(1) incarceration for a term not less than three days, nor more than six months, under the procedures set forth in Section 1-2-1.1 of the Illinois Municipal Code, as amended, and the Illinois Code of Criminal Procedure of 1963, as amended; and/or

(2) community service of not less than ten hours, nor more than 100 hours; and

(3) a fine of not less than \$200.00, nor more than \$500.00 for the first offense; and a fine of not less than \$500.00, nor more than \$3,000.00 for the second offense; and a fine of not less than \$3,000.00, nor more than \$5,000.00 for the third and each subsequent offense.

A separate and distinct offense shall be committed for each permit which is required but has not been obtained, and each day that the violation continues.

If an employee of a builder, contractor or subcontractor is charged with violating this subsection, it shall be a defense that the employee is not an owner, manager, or person exercising control over the builder, contractor or subcontractor and did not have prior notice that the builder, contractor or subcontractor had failed to obtain a permit.

B. It shall be unlawful for any person to fail to post any permit as required by Section 13-32-010 of this Code. Any person who violates this subsection shall be fined not less than \$200.00, nor more than \$500.00 for each day that work proceeds without the permit having been posted.

13-12-080 Failure to acquire permits for construction, alteration, installation, repair or razing – Stop work order.

(A) Any city official charged with responsibility for administering this Code shall without delay issue a stop work order directing that the following prohibited activities cease and desist immediately:

(i) Any construction, alteration, installation, repair or razing of any building, structure, premises, or part thereof which is being done or has been done without any permit required by this Code; or

(ii) Any construction, alteration, installation, repair or razing of any building, structure, premises or part thereof which is being done or has been done contrary to the drawings or plans which the appropriate department or agencies of the city approved when issuing any permit; or

(iii) Any maintenance or operation of any building, structure, premises, mechanical installation, equipment or part thereof which is being done without any permit or certificate required by this Code; or

(iv) Any construction, alteration, installation, repair or razing of any building, structure, premises or part thereof which is being done or has been done by workers lacking a license required under this Code for such work or which is being done or has been done by workers required by the Code to be listed on the building permit application who were not listed.

No stop work order may be issued to prohibit any construction, alteration, installation, repair or razing of any building, structure, premises or part thereof that is performed pursuant to a valid permit issued by the building commissioner for any reason not specified in this section, unless such order is necessary to prevent an imminent threat to the safety of the public.

Any city official who has reason to believe that (1) any construction, alteration, installation, repair or razing of a building, structure, premises or part thereof is being done or has been done in violation of a stop work order, or that (2) any building, structure, premises, mechanical installation, equipment or part thereof is being maintained or operated in violation of a stop work order shall immediately request the corporation counsel to seek without delay any remedy provided by the law.

13-32-035 Stop work orders – New or revised permit – Fees.

(a) Whenever any person or entity shall apply for a new or revised permit from the department of buildings as a result of a stop work order issued pursuant to Section 13-12-080 or other action taken by the city because the work being done or which has been completed was performed either without a permit or not in conformity with the terms of the permit, the permit fee assessed for the new or revised permit shall be as follows:

(i) for all permits where the regular fee is an amount less than \$500.00 as provided in Sections 11-4-130, 13-20-540, 13-32-310, a penalty of 100 percent of the regular permit fee shall be assessed in addition to the regular permit fee;

(ii) for all permits where the regular permit fee is an amount greater than \$500.00 but less than \$3,000.00 as provided in Sections 11-4-130, 13-20-540, 13-32-310, a penalty of 100 percent of the regular permit fee shall be assessed for the first \$500.00, and for each increment of \$500.00 or fraction thereof, a penalty of \$125.00 shall be assessed in addition to the regular permit fee;

(iii) for all permits where the regular permit fee exceeds \$3,000.00 as provided in Sections 11-4-130, 13-20-540, 13-32-310, a penalty of 100 percent of the regular permit fee shall be assessed for the first \$1,000.00, and for each increment of \$500.00 or fraction thereof, a penalty of \$75.00 shall be assessed in addition to the regular permit fee.

(b) In addition to any fee assessed pursuant to subsection (a), a penalty of \$1,000.00 shall be assessed whenever any person or entity shall apply for a new or revised permit from the department of buildings as the result of a stop work order issued pursuant to Section 13-12-080 or other action taken by the city because the work being done or which has been completed was performed by a person or persons lacking a license required under the Code for such work or was performed by a person or persons required by the Code to be listed on the building permit application who were not listed.

13-32-130 Operations without permit – Stop work order.

No person or entity shall begin any work for which a building permit is required or any work of excavation in preparation therefor until the permit has been issued. If any person or entity violates this section, the building commissioner shall order the work stopped at once as provided in Section 13-12-080 and enforce the stop order in addition to the penalties for the violation provided in Sections 13-12-050 and 13-32-035.

13-32-120 Construction contrary to permit – Stop work order.

It shall be unlawful for any owner, agent, architect, structural engineer, contractor, or builder engaged in erecting, altering, or repairing any building, structure or portion thereof to make any departure from the drawing or plans, as approved by the building commissioner, of a nature which involves any violation of the provisions of this Code on which the permit has been issued. Any such departure from the approved drawings and

plans involving a violation of requirements, shall operate to void the permit which has been issued for such work.

Where any work done under a permit authorizing erection, alteration, or repair of a building, structure or portion thereof, is being done contrary to the approved drawings and plans, the building commissioner or the president of the board of health shall have power to stop such work at once as provided in Section 13-12-080, and to order all persons engaged thereon to stop and desist from further work, until such time as the building commissioner or the president of the board of health, has received affidavits that the work to be performed will be done in accordance with the approved drawings and plans. Nothing in this paragraph shall be construed to prevent minor changes in arrangement or decoration which do not affect the requirements of any provisions of this Code, except where they affect significant features, as communicated in the report of the commission on Chicago landmarks, of a Chicago landmark designated in accordance with applicable provisions of Chapter 2-120 of this Code.

What is the building permit fee formula and has it changed?

Answer:

The building permit fee formula is in section 13-32-310 (below).

Construction factor \times Scope of review factor \times Area of work = Permit fee

The above formula has been in effect since June 1, 2008. While the formula was not amended, the fees were updated in the 2016 Revenue Ordinance which was effective January 1, 2016. The factors utilize the Tables A through D in section 13-32-310 along with the area of work. The fee is the same for permits that go through Developer Services or Standard Plan Review.

As examples:

1. A new wood frame construction 2-story 2,500 square foot single family home would have a permit fee of \$450.00.

Construction factor of 0.36 \times Scope of review factor of 0.5 \times Area of work of 2,500 sf = \$450.00

2. A new steel/masonry construction 10-story 150,000 square foot hotel would have a permit fee of \$81,000.

Construction factor of 0.54 \times Scope of review factor of 1.0 \times Area of work of 150,000 sf = \$81,000

13-32-310 Permit fees – Computation.

- (a) *Permits requiring plans – Calculation of fee.* If building plans or drawings meeting the requirements of Chapter 13-40 are required under this code in order for a permit to be issued or for any type of work described in Tables (C) or (D) of this section, the permit fee shall be calculated using the following formula:

Provided, however, that if the permit fee calculated under this subsection is less than the minimum permit fee indicated in Table 13-32-310(C) or (D), the minimum permit fee indicated in Table 13-32-310(C) or (D), as applicable, shall be assessed. Provided, further, that if the work identified in the permit application (i) also requires a flat fee under subsection (b) of this section, and (ii) any column in Table 13-32-310(E) contains the notation “(2)” or “(3)”, the applicable flat fee shall be assessed in addition to the permit fee required under this subsection. If more than one minimum flat fee applies to the project identified in the permit application, the greater minimum flat fee shall be assessed. Provided, however, if any applicable column in Table 13-32-310(E) contains the notation “(3)”, all applicable minimum flat fees shall be assessed separately.

For purposes of this subsection (a):

The “construction factor” shall be determined using Table 13-32-310 (A) or (B), as applicable.

The “scope of review factor” shall be determined using Table 13-32-310 (C) or (D), as applicable.

The “area of work” shall be calculated based on the nature of the permitted work to be done, as follows:

For new construction: The “area of work” means the total square foot area of the building identified in the permit application, measured to the outside finished surface of the exterior walls. Provided, however, that if an exterior wall is a shared wall, the area of work shall extend to the middle of the shared wall.

The following spaces shall be included in the calculation of the total square foot area of a building: (1) any finished or unfinished basement area with a ceiling height of 5-0 or more; (2) any mezzanine; (3) any penthouse; (4) any enclosed projection from a building, such as a bay, with floor area; (5) any floor area covered by a roof or upper deck, such as an open porch; and (6) any finished or unfinished area under a sloping roof with a ceiling height of 5-0 or more, unless roof trusses prevent any usable space.

The following spaces shall not be included in the calculation of the total square foot area of a building: (1) the area under the overhanging eaves of a building; (2) balconies; and (3) the area of any deck, unless the deck is subject to the requirements of Chapter 4-388 of this code.

Construction built over an existing foundation with no remaining existing structure above grade shall be considered to be new construction. If a portion of an existing structure remains above grade, the construction shall be considered to be an alteration and/or addition.

For phased construction: The “area of work” means the scope of work proposed for completion during the specific phase of construction for which a permit is sought and shall be calculated in the same manner that the “area of work” is calculated for new construction. If the scope of work proposed for completion includes the construction of caissons, piles, grade beams, slurrywalls or a full foundation, the area of work shall be the footprint of the building under construction. If the scope of work proposed for completion includes the construction of floor areas above the foundation but below grade, the area of work shall be the total square foot area of each floor constructed within the perimeter of the foundation. For purposes of calculating the permit fee for the specific phase of construction for which a permit is sought, any area on phased construction plans submitted for “reference only” shall not be included in the area of work.

For alterations, renovations or repairs: The “area of work” means the floor area affected by the intended scope of work. The affected square foot floor area includes (1) areas of alteration or renovation within the existing volume of space; and (2) areas in which existing elements or building systems are repaired or replaced.

The following spaces shall not be included in the calculation of the area in which the permitted alteration, renovation or repair will occur: (1) the square footage of the building's envelope or perimeter walls, if no changes are made to the envelope or perimeter walls from the exterior or interior side of the building's envelope or walls; and (2) areas in which no work requiring a permit is to be performed; and (3) areas in which piping is installed for the sole purpose of providing utility services to the area of work, if installation of the piping does not alter or require the alteration of the space through which the pipe(s) pass.

If the area of alteration, renovation or repair is unclear or disputed, the demising walls of the space under the control of the permit applicant shall be considered to be the “area of work.”

For additions: The “area of work” means the total square foot area of the addition identified in the permit application, measured to the outside finished surface of the exterior walls or to the middle of any shared wall.

The following spaces shall be included in the calculation of the total square foot area of an addition: (1) any finished or unfinished basement area with a ceiling height of 5-0 or more; (2) any mezzanine; (3) any penthouse; (4) any enclosed projection from a building, such as a bay, with floor area; (5) any floor area covered by a roof or upper deck, such as an open porch; (6) any finished or unfinished area under a sloping roof with a ceiling height of 5-0 or more, unless roof trusses prevent any usable space; and (7) any area in which other work requiring a permit will occur.

The following spaces shall not be included in the calculation of the total square foot area of an addition: (1) the area under the overhanging eaves of a building; (2) balconies; and (3) the area of any deck, unless the deck is subject to the requirements of Chapter 4-388 of this code.

For decks, porches, stairs, and balconies: The “area of work” means the total square foot area of the deck, porch, stairs or balcony, measured from the exterior walls of the building to the outside of the railing or, if a deck or stairs lacks railings, to the outside perimeter of the deck or stairs.

For moved buildings: The “area of work” means the total square foot area of the building identified in the permit application, measured to the outside finished surface of the building's exterior walls.

The following spaces shall be included in the calculation of the total square foot area of a moved building: (1) any finished or unfinished basement area with a ceiling height of 5-0 or more; (2) any mezzanine; (3) any penthouse; (4) any enclosed projection from a building, such as a bay, with floor area; (5) any floor area covered by a roof or upper deck, such as an open porch; and (6) any finished or unfinished area under a sloping roof with a ceiling height of 5-0 or more, unless roof trusses prevent any usable space.

The following spaces shall not be included in the calculation of the total square foot area of a moved building: (1) the area under the overhanging eaves of a building; (2) balconies; and (3) the area of any deck, unless the deck is a rooftop deck subject to the requirements of Chapter 4-388 of this code.

For facade work: If the work to be permitted involves the entire facade of any exterior wall of a building, the “area of work” means the total square foot area of each exterior wall on which such facade work will be done, measured from the point where the

building intersects the ground to the top of the parapet or to the intersection between the wall and an overhanging roof. If the work to be permitted involves only a portion of any exterior wall of a building, the “area of work” means the total square foot area of each such portion of the exterior wall on which such facade work will be done and the surrounding area that will be disturbed by such work, measured by multiplying the height of each such portion times the width of each such portion on the plane of the facade. Provided, however, that if the permitted work to be done involves facade work on 75% or more of an exterior wall of the building, such work shall be deemed to involve the entire facade of such exterior wall and shall be measured accordingly.

Definitions: As used in this section:

“Alteration” means any change to or reconfiguration of an existing space that alters the footprint, floor plan or volume of such existing space.

“Equipment regulated by the department of health” means any equipment, device, vessel or area within a facility regulated under this code by the department of health of the City of Chicago including, but not limited to, any of the following:

(i) Fuel-burning Equipment (including, but not limited to, boilers, furnaces, ovens and crucibles);

(ii) Industrial Process Equipment (including, but not limited to, tanks, kettles, converters, kilns, crucibles, stills, dryers, roasters, crushers, grinders, blenders, mixers, reactors, regenerators, separators, filters, columns, classifiers, screens, quenchers, cookers, towers, washers, scrubbers, mills and condensers);

(iii) Pollution Control Devices (including, but not limited to, bag houses, cyclones, electrostatic precipitators, thermal oxidizers, afterburners, absorbers, filters, dry collectors and wet collectors);

(iv) Unfired Pressure Vessels (including, but not limited to, jacketed kettles, tanks under pressure and indirect fired vessels);

(v) Motor Vehicle Repair Shops (including, but not limited to, paint spray booths, prep areas and mixing areas);

(vi) Dry Cleaning Facilities (including, but not limited to, dry cleaning machines and boilers);

(vii) Incinerators (including, but not limited to, pathological waste-, thermal- and catalytic- incinerators);

(viii) Food Preparation Units (including, but not limited to, kitchen hoods); and

(ix) Process Areas (including, but not limited to, areas used for grinding, sawing, cutting, packaging, assembling, machining, blending and mixing);

(x) Generators (including, but not limited to, emergency generators and standby or discretionary generators).

“Repair” means the use of identical or similar materials to mend, fix, patch, cure, refurbish or otherwise salvage a portion of an existing object or space in order to maintain or extend the lifespan of such object or space.

“Renovation” means any change to or reconfiguration of an existing object or space other than alteration, repair or replacement.

“Replacement” means the substitution in its entirety of a new object for an existing object, under circumstances where (1) the dimensions and location of the new object are identical to or reasonably match the dimensions and location of the existing object; and (2) the design, profile, function and general appearance of the new object are identical to or reasonably match those of the existing object.
