ID#: 03-01 Pre-Hearing Question - Salary Increases

The following information is in response to questions posed at our department's hearing on October 31, 2019 to discuss the 2020 budget.

Alderman Reilly requested information on the number of non-union employees to receive salary increases in 2020 budget.

Based on the analysis of the data, DHR recommended that the Office of Inspector General's (OIG) titles of Investigator II and Investigator III be regraded to GY08 and GY09 respectively. The Investigator I cadre will remain as is. As a result, 7 of the 17 OIG Investigators will receive raises in 2020. The breakdown of the raises is: five Investigator IIIs will receive a salary increase of \$3,300 each and two Investigator IIs will receive a salary increase of \$1,980 each. The total increase is \$16,896 which has been offset by redirecting non-personnel funds previously allocated for new OIG computers.

<u>Background</u>: During 2019, the Department of Human Resources (DHR) conducted an internal and external salary review of the OIG's Investigator Is, Investigator IIs, and Investigator IIIs, to determine appropriateness of compensation level. DHR obtained compensation data for investigators conducting similar work as OIG's investigators from the City of New Orleans, Los Angeles County, Cook County, City of Chicago Civilian Office of Police Accountability, DHR Equal Employment Opportunity, and City of Chicago Commission on Human Relations.

The following information is in response to questions posed at our department's hearing on October 31, 2019 to discuss the 2020 budget.

Alderman Reilly requested a list of savings and cost-efficiencies due to zero-based budgeting.

The Office of Inspector General (OIG) has participated in zero-based budgeting every budget year since 2013. As a result of applying zero-based budgeting for 2020, OIG identified efficiencies in technology costs that resulted in redirecting funds from non-personnel to increasing salary costs due to annual merit increases of \$116,000. This action allowed OIG to submit a 2020 budget that did not increase over OIG's appropriated 2019 budget.

The following information is in response to questions posed at our department's hearing on October 31, 2019 to discuss the 2020 budget.

Alderman Moore requested an updated review of operational savings of the garbage pickup, which the Inspector General noted for consideration of a full performance audit in future audit plans and cycles. In the meantime, we refer the Committee to an OIG Audit of DSS Garbage Collection performance in 2015.

The findings of our audit pointed to opportunities for DSS to build on the substantial efficiencies and savings realized by its conversion to grid-based garbage collection. In 2016, a follow-up of DSS Garbage Collection performance audit was conducted and concluded that DSS has begun to implement corrective actions related to the audit findings, but that the recommended improvements to the grid-based collection system at that time were still in progress. 

ID#: Follow-up, Pre-Hearing Questions Discussed on the Record During Budget Hearing

The following information is in reply to Alderman Reilly's request for written responses to prehearing 2020 budget questions that were discussed on the record during our department's hearing on October 31, 2019. Written responses to questions 4-6 were provided through the Chair on November 4th, 2019.

As City Council is aware, the Office of Inspector General (OIG) has a budget floor that is written into OIG's Municipal Code that results in OIG's budget increasing as the City's budget increases across all funds. This process may require technical amendments to OIG's budget submission because OIG's final budget is not known until after the Office of Budget and Management (OBM) balances the City's annual budget. The following responses are based on OIG's budget post-technical amendments that were agreed to by OBM prior to OIG's budget hearing.

- Reilly: Changes in headcount projected for 2020
 Response: OIG FTE will increase from 106 to 107. The new position is a Complaint Intake Specialist assigned to OIG's Investigations Section. The salary of this position is \$44,604.
- 2. **Reilly**: Number of funded vacancies and breakdown for 2020 **Response**: OIG will have 11 funded vacancies. See attached for a 2020 breakdown.
- 3. **Reilly**: Number of vacancies being cut what positions (job titles) are being eliminated **Response**: OIG was required to cut an Associate General Counsel position during the City's vacancy reduction exercise. The salary for this position was \$123,996. This was a new position that OIG included in its neutral 2020 budget submission in July. The position was funded by redirecting cost from its non-personnel account.
