The attached information is in response to questions posed at our department's hearing on November 5, 2019 to discuss the proposed 2020 budget.

Alderman Reboyras asked for information about our community health assessment (CHA) process, and specifically data related to healthcare access.

The Chicago Department of Public Health (CDPH) conducts a community health assessment and develops a community health improvement plan every five years. CDPH completes this work in collaboration with the Partnership for Healthy Chicago (Partnership), a coalition of over 40 public and private organizations representing the broad sectors of the public health system.

For our most recent assessment process, we collected information from community and public health system members. We analyzed both quantitative data and qualitative input from residents on health and the root causes of health inequities. CDPH held community meetings to review findings from the assessments, then identified cross-cutting goals. Strategy and measure development is currently underway with more than 650 people volunteering to participate on issue-specific work groups. The product of this process will be the release of our Healthy Chicago 2025 plan, expected in early 2020.

Access to healthcare, along with human service resources, emerged as one of the key priorities in this planning process. Quantitative data on healthcare access is located on the Chicago Health Atlas (chicagohealthatlas.org) and in the newly published Healthy Chicago 2025 Data Compendium (available on CDPH's website). Detailed qualitative data from the focus groups and surveys will be available when the Healthy Chicago 2025 Community Health Assessment is published next year.

The attached information is in response to questions posed at our department's hearing on November 5, 2019 to discuss the proposed 2020 budget.

Aldermen Burnett and Dowell asked for a summary of organizations who received technical assistance funding. These funds were released in 2017 to existing HIV prevention delegate agencies to allow for infrastructure development related to forthcoming HIV funding opportunities. Funding was one-time, and CDPH did not impose a ceiling on funding requests. Twenty-seven organizations were eligible to apply. Fifteen organizations submitted proposals, and all 15 were funded. A total of \$819,131 was awarded.

The attached information is in response to questions posed at our department's hearing on November 5, 2019 to discuss the proposed 2020 budget.

Aldermen King and Waguespack asked for a list of the publicly funded clinics providing mental health services, with the number and demographics of patients served.

Please see the enclosed spreadsheet for a list of federally qualified health centers (FQHCs) as listed by the U.S. Human Resources and Services Administration (HRSA), along with City of Chicago and Cook County sites. Some of the sites are school based. We have also included additional FQHC sites that we know to be located in Chicago. In total, we have listed 146 publicly funded sites.

We do not currently have volume and demographic figures for patients receiving mental health services at each of these clinics. However, FQHC networks are mandated to report total client data to HRSA. Those figures are publicly available here: https://bphc.hrsa.gov/datareporting/. As an example, Access Community Health Network—the largest FQHC network in Chicago—reported a 2018 patient load of 175,343, of which 92.8% belonged to a racial or ethnic minority, 68.3% were at or below the poverty line, and 96.6% were at or below 200% of the poverty line.

Alderman Reilly asked for a description of savings and cost efficiencies realized through zero-based budgeting.

Outside of incremental costs related to new initiatives for Mental Health, Violence Prevention and Chronic Disease, CDPH submitted a relatively flat budget versus 2019's appropriation. As we prepared our budget, we went through the exercise of evaluating each dollar and service provided and determined what was submitted is the minimum needed. CDPH's work is predominantly funded by external grants; the expenses charged to the corporate fund, about 20 percent of our budget, are essential to operations that cannot otherwise be funded.

Alderman King asked for information regarding the investment per capita in CDPH clinics and FQHCs.

The City spends approximately \$4,200 per client at the CDPH-run mental health clinics, and an average of just over \$2 million per clinic. Under strategy number one of the Framework for Mental Health Equity, we will invest \$4.5 million in 15 non-CDPH clinics such as federally qualified health centers and community mental health centers; accordingly, we expect the average award to be about \$300,000. Ultimately, final award amounts and the dollars spent per patient will depend upon the number of successful responses and the scopes of work that applicants propose.

The attached information is in response to questions posed at our department's hearing on November 5, 2019 to discuss the proposed 2020 budget.

Alderman Tunney asked for a summary of CDPH food citations, to include revenue from fines, total number of inspections and type.

There are three levels of violations for food inspections.

- Core (No Citation Fee): Usually relates to general sanitation, cleanliness, structure, and general maintenance.
- Priority Foundation Violations (\$250 Citation Fee): Violations include process errors, evidence of pests, training, equipment, documentation, and labeling.
- Priority Violations (\$500 Citation Fee): Violations include procedures by the operator that contribute directly to foodborne illness. This would include lack of equipment to control food temperatures, pest infestation, documentation, and labeling that could lead to allergic reactions or public health concerns.

The attached information is in response to questions posed at our department's hearing on November 5, 2019 to discuss the proposed 2020 budget.

Alderman Lopez asked for information about the lead predictive model.

The Lead Paint Hazard Predictive Model pilot provides an opportunity to prevent lead poisoning before it happens by identifying children who might be at risk. CDPH, with its partners at the Department of Innovation and Technology, AllianceChicago, and the University of Chicago's Center for Data Science and Public Policy, created a model that combines data from multiple sectors - including public health, census and buildings - to identify buildings that are likely to have lead paint. The model assigned a risk score to approximately 770,000 homes using data that includes socioeconomic status, blood lead levels, home inspection records, building permits, building violations, and building age. The full methodology is described in a report available at http://www.dssgfellowship.org//wp-content/uploads/2016/01/p2039-potash.pdf.

AllianceChicago, a network of federally qualified health centers, developed software in their electronic health records that allows clinicians to access the lead paint risk score for a patient's home at the point of care and send inspection requests to CDPH. The CDPH lead inspectors will

do a visual inspection and, if they see potential lead hazards, complete a full lead inspection and develop an abatement plan. The work was funded by the Robert Wood Johnson Foundation.

We have also partnered with Sinai Hospital community health workers (CHWs) to assess the feasibility, impact and cost effectiveness of using CHWs to conduct proactive visual inspections for lead-based paint hazards in homes of WIC clients on the south and west sides identified as high risk by our model. This project is funded by the U.S. Department of Housing and Urban Development.



The attached information is in response to questions posed at our department's hearing on November 5, 2019 to discuss the proposed 2020 budget.

Alderman La Spata asked for information regarding the distribution and administration of an additional \$8 million in funds for violence prevention services.

CDPH will be partnering with the Mayor's Office of Public Safety (MOPS) to administer a new \$8 million investment in violence prevention services. CDPH will work in partnership with MOPS to draft the respective Requests for Proposals (RFP), oversee the application evaluation/scoring process, and then work with successful respondents to execute contracts and develop budgets and work plans. Ongoing technical assistance for successful respondents may be provided by members of either the CDPH Violence Prevention program or staff members from MOPS.

The \$8 million investment will include \$6 million in new street outreach/violence prevention funds invested in communities with the highest rates of violence. An additional \$1.5 million will support the creation of victim services units (within the street outreach teams) which will provide traumainformed support and case management/mental health linkage services to people impacted by violence. Lastly, the investment will include \$500,000 for trauma-informed training to support community members in the communities with the highest rates of violence.

Alderman Mitts asked about Mental Health training for communities.

The Chicago Department of Public Health supports and invests in *Mental Health Awareness* and *Mental Health First Aid* training.

Mental Health Awareness training is designed to reduce stigma, increase understanding, increase responsiveness, and encourage help-seeking. In addition, it includes how to request Crisis Intervention trained police officers for support. Mental Health First Aid training is a course that teaches how to assist someone who is developing a mental health problem or experiencing a mental health crisis. Both trainings help participants identify, understand, and respond to signs of addictions and mental illnesses.

These trainings are conducted in-person and in community settings. The Kennedy Forum organizes and coordinates the trainings and subcontracts with NAMI, Sertoma Center and Trilogy to conduct the trainings.

In addition, the Emergency Preparedness and Response program provides Psychological First Aid training to City employees, healthcare systems and community-based organizations. This training provides non-clinical interventions to assist children, adolescents, adults and families in the immediate aftermath of a public health emergency, disaster or traumatic event such as an open act of violence.

The attached information is in response to questions posed at our department's hearing on November 5, 2019 to discuss the proposed 2020 budget.

Alderman Mitts asked for data on sexual abuse, broken out by gender.

CDPH reports data on adult criminal sexual assault https://chicagohealthatlas.org/indicators/sexual-assault. In 2018, there were 1,810 reported offenses of sexual assault in the city of Chicago. We do not have this information by gender or by age group. This data comes from the Chicago Police Department IUCR reporting system.

In Illinois, the InfoNet system collects data on victims served by rape crisis centers, rapes reported to police, and reports of child sexual abuse to DCFS. In Illinois during 2015, there were an estimated 7,500 female victims of sexual violence. Approximately, 3,100 were adult victims of rape or sexual abuse, 1,200 were adult survivors of child sexual abuse and 3,200 were child victims of sexual abuse.

The attached information is in response to questions posed at our department's hearing on November 5, 2019 to discuss the proposed 2020 budget.

Alderman Lopez asked for information on CDPH's position and efforts on vaping.

Vaping is a danger to our young people, threatening to hook another generation on nicotine. We were the first city in the U.S. to add vaping to our Clean Indoor Air Ordinance, and in 2015 we enacted the first municipal e-cigarette tax in the nation (which we later raised). We have launched media campaigns such as "Vaping: It's Still Addiction" and worked with CPS to update their policy manuals to cover vaping. We also prohibit the sale of flavored tobacco within 500 feet of high schools, covering most vape sales. In addition, we have undertaken a number of anti-tobacco measures that include vaping, such as raising the purchasing age to 21 and banning coupons.

As Mayor Lightfoot announced in September, we intend to toughen the restrictions on flavored tobacco products, which are young people's main gateway to tobacco use. Such restrictions would include the sale of flavored vape liquid. In the meantime, we are working with the state health department to monitor the recent incidence of lung disease associated with vaping.

Alderman Lopez asked for details on the working group addressing concerns with recreational cannabis.

The Mayor's Office is coordinating actions between all city departments and sister agencies in preparation for the January 1, 2020 effective date of the state Cannabis Regulation and Tax Act. We are working through the Mayor's Office to ensure public health protections are being addressed in the City's policies regarding zoning of cannabis businesses, public safety and enforcement, and consumption. We are reviewing public health literature on cannabis and best practices from other jurisdictions with legalized commercial cannabis and will work with partner organizations in public health and healthcare.

The attached information is in response to questions posed at our department's hearing on November 5, 2019 to discuss the proposed 2020 budget.

Alderman Lopez asked how our new mental health plan of servicing clients is different from current services, how many clients the new plan will serve, and where services will be provided.

In 2018, CDPH served 2,408 clients at its five mental health clinics. The Framework for Mental Health Equity expands on this work in a number of ways.

First, we propose to enhance services and expand the client load at those five clinics. We also plan to enhance services and increase the number of clients at 15 nonprofit, publicly funded sites such as federally qualified health centers and community mental health centers. These will be in communities of high need, particularly those hard-hit by trauma.

Second, we would extend mental health services beyond the brick-and-mortar clinics to reach residents who have difficulty accessing them. Many of these residents have deep, complex needs and cycle through emergency rooms and the criminal justice system; our funding would go toward outreach teams and other community providers to treat the underlying needs. The funding beyond clinics would also support trauma-informed services to people in the aftermath of violence,

whether through outreach teams, school-based programs, or other services. As in the first strategy, we will focus on areas of high need and trauma.

Third, our plan would invest in making the City a system coordinator to link patients to care when they don't know where to go, identify service gaps at the neighborhood level, create strategies to close those gaps, and conduct anti-stigma campaigns.

We expect tens of thousands of additional residents will be served using this funding. The exact neighborhoods with expanded services will be determined through an RFP process in which we will receive proposals and award grants. However, as mentioned, at least 15 underserved areas will receive services through brick-and-mortar facilities, and many more will be served through outreach and system coordination.

The attached information is in response to a letter dated November 19, 2019 requesting written responses to questions posed at our department's hearing on November 5, 2019 to discuss the proposed 2020 budget.

Alderman Reilly asked CDPH to provide the information listed below and the responses are immediately following each request:

• Changes in headcount projected for 2020

Headcount was initially projected to increase by 14. Since the budget was introduced, an additional 5 positions were added in our mental health clinics, bringing the total projected headcount increase to 19 positions.

Number funded vacancies and breakdown for 2020

We have 134 funded vacancies, including the 5 new positions added above. We expect this same number as we go into 2020 with the addition of any retirements and resignations that occur before the end of 2019.

• Number of vacancies being cut – what positions (job titles) are being eliminated?

We cut the following 8 Corporate vacancies: Administrative Assistant III, Communicable Disease Control Investigator I, Director of Information Systems, Public Health Nurse II, Physician, Sanitarian II, and 2 Staff Assistants

Number of non-union employees to receive salary increased in 2020 budget

We have 25 non-union employees eligible receive a step increase in 2020 pending a satisfactory performance review.

• Description of outsources services projected for 2020

These services include temporary psychiatry, removal and processing of clinical laboratory samples, collection and disposal of hazardous chemicals and consumer electronics, pharmaceutical storage and inventory management, city-wide survey of residents' health, vector control services, document destruction, and health promotion and education services.

List of savings and cost-efficiencies due to zero-based budgeting

Outside of incremental costs related to new initiatives for Mental Health, Violence Prevention and Chronic Disease, CDPH submitted a relatively flat budget versus 2019's appropriation. As we prepared our budget, we went through the exercise of evaluating each dollar and service provided and determined what was submitted is the minimum needed. CDPH work is predominantly funded by external grants; the expenses charged to the corporate fund, about 20% of our budget are essential to operations that cannot otherwise be funded.
