The following information is provided in response to questions posed at our department's hearing on November 9<sup>th</sup> to discuss the proposed 2025 budget.

Alderman Mitchell asked COPA to break out "shooting cases."

In 2024, COPA closed 40 officer-involved shooting (OIS) investigations.<sup>1</sup> Within the 40 closed OIS investigations, 56 CPD members received an allegation involving "weapon discharge." Among the 56 members:

- 13 members had a finding of sustained for least one allegation involving weapon discharge.<sup>2</sup>
- 44 members had a finding other than sustained for at least one allegation involving weapon discharge.<sup>3</sup>

<sup>&</sup>lt;sup>1</sup> This figure does not include member firearm discharges involving an animal, accidental discharge, or suicide. <sup>2</sup> Note that each OIS investigation may involve more than one Department member. Additionally, members may receive more than one allegation of weapon discharge per OIS incident. For example, multiple CPD directives may be applicable to the use of force evaluation (resulting in multiple allegations), the incident involved firearm discharge at multiple individuals, and the incident involved assessment of multiple volleys of shots fired (each evaluated independently).

The following information is provided in response to questions posed at our department's hearing on November 9<sup>th</sup> to discuss the proposed 2025 budget.

Alderman Mitchell asked COPA to list the nature of sustained findings in shooting cases.

In 2024 (as of November 25), COPA closed 40 Officer-Involved Shooting (OIS) investigations<sup>1</sup> which contained 56 independent member firearm discharges.<sup>2</sup>

Within these 40 concluded OIS Investigations, COPA sustained the following additional allegations, in order from most to least:

The following information is provided in response to questions posed following our department's hearing on November 9<sup>th</sup> to discuss the proposed 2025 budget.

Alderman La Spata asked for COPA's current compliance with the consent decree, as well as how a decrease of \$240,000 in COPA's Consent Decree line will impact the department's ability to comply.

The Independent Monitoring Team's 10<sup>th</sup> Semi-Annual Monitoring Report, covering the period of 1/1/24 through 6/30/24, reflects COPA as having achieved 100% preliminary compliance, 99% secondary compliance, and 90% full compliance (i.e., adherence to policies and training within day-to-day operations) for the paragraphs that COPA is responsible.

Though COPA's proposed 2025 budget appears to reflect a \$240,000 reduction, it should be noted that \$40,000 of that total was relocated from COPA's Consent Decree line (9295) to Rental of Property (0155). These funds were shifted to enhance budget transparency.

In advance of OBM's efforts to address budget shortfalls through reduction exercises with departments beginning in July 2024, COPA was prepared to reduce funding in its Consent Decree line. In prior years, COPA has not expended all the funds available via the line (totaling \$1,015,000 in prior years). For example, as of time of COPA's 11/9/24 budget hearing, approximately \$461,580 in funding remained under the line. Therefore, COPA is confident that a \$200,000 reduction would not substantially impact the department's progress toward Consent Decree compliance given the progress the department has made towards compliance and historical funding expended in the line.
