

The 2025 Draft Action Plan Budget reflects an estimated total funding of \$133,993,000 from the U.S. Department of Housing and Urban Development (HUD). These funds are designed to support programs that benefit low- and moderate-income residents throughout Chicago. The funding is allocated across four key HUD programs:

- 1. Community Development Block Grant (CDBG):**
  - Provides flexible funding to address housing, community development, and public services needs.
  - Total Allocation: **\$77,613,000** (including program income).
- 2. HOME Investment Partnerships Program (HOME):**
  - Supports the development and preservation of affordable housing.
  - Total Allocation: **\$36,847,000** (including program income).
- 3. Emergency Solutions Grant (ESG):**
  - Focuses on homelessness prevention and rapid rehousing services.
  - Total Allocation: **\$6,733,000**.
- 4. Housing Opportunities for Persons with AIDS (HOPWA):**
  - Provides housing assistance and supportive services for individuals living with HIV/AIDS.
  - Total Allocation: **\$12,800,000**.

Department of Housing (DOH)	\$61,686,000	Affordable housing development, housing preservation, homeownership counseling, construction compliance, and tenant legal services.
Department of Fleet and Facility Management (2FM)	\$563,000	Environmental reviews to ensure federally funded projects comply with environmental regulations.
Chicago Department of Public Health (CDPH)	\$26,267,000	Housing assistance for people with AIDS (HOPWA), lead poisoning prevention, violence prevention, and mental health services.
Chicago Commission on Human Relations (CCHR)	\$1,309,000	Education and outreach on human rights, conflict mediation, and fair housing complaint resolution.
Mayor’s Office for People with Disabilities (MOPD)	\$5,308,000	Home modifications for accessibility, independent living services, and resources for individuals with disabilities.
Department of Family and Support Services (DFSS)	\$31,374,000	Homeless services, senior services, domestic violence support, workforce development, and emergency food assistance.
Department of Planning and Development (DPD)	\$1,677,000	Planning and administration for neighborhood revitalization, housing strategies, and infrastructure improvements.
Department of Water Management (DWM)	\$4,768,000	Lead service line replacement to ensure safe drinking water for low- and moderate-income households.
