Dear Ms. Barnes:

In response to your recent request, please be advised that the subject property is zoned C3-5 Commercial, Manufacturing and Employment District. Pursuant to Section 17-3-0207-AAA (1) of the Zoning Ordinance ("Ordinance"), an adult use cannabis dispensary requires special use approval from the Zoning Board of Appeals. Additionally, an adult use cannabis dispensary shall be located no closer than 500 feet from any school, pursuant to Section 17-9-0129 (3) of the Ordinance. According to our records, there are no schools within 500 feet of the subject property. The applicant will need to provide confirmation of this from the Illinois Board of Education as part of their special use application.

Finally, before a public hearing is held by the Zoning Board of Appeals to consider the special use application, the applicant must hold at least one community meeting in the ward in which it is proposed. Please refer to Section 17-13-0905-G of the Ordinance for more information about the community meeting process.

This letter may be used as your official denial to file for the required special use with the Zoning Board of Appeals.

PROJECT NARRATIVE:

Proposed Special Use 1001 West North Avenue, Chicago, Illinois

The subject property is generally located at 1001 West North Avenue, Chicago, Illinois ("Subject Property" or "Subject Site"). The Site, in its entirety, comprises the entire southwest corner of North Avenue and Sheffield Avenue, with Kingsbury Street bordering the property to the west.

The Property is located in a C3-5 Commercial, Manufacturing and Employment District, within the Near North (Lincoln Park) Neighborhood (27th Ward) and within the North Zone, as recently codified pursuant to the Section 17-7-0100, et seq. (as amended) of Title 17 of the Municipal Code of Chicago.

The Subject Site is presently improved with a one-story commercial building, which comprises a single unit (+/- 4,600 square feet), within an existing one-story 'strip-center' facility ("Operating Premises"). The Property also includes a surface parking lot, with off-street parking for at least twenty-one (21) vehicles.

The Applicant – MME 1001 North Retail LLC, generally d/b/a MedMen Cannabis Dispensaries ("MedMen"), currently operates a medical cannabis dispensary – at 1804 Maple Avenue, Evanston, Illinois 60201, pursuant to State License Disp. No. 000009 ("Evanston Medical License"), which was issued by the State of Illinois – Department of Financial and Professional Regulation (IDFPR), as well as a Special Use, granted by the Evanston Zoning Board of Appeals (ZBA). *[MedMen recently acquired the Evanston Medical License, and all rights and obligations associates with the same, from Pharmacann LLC, d/b/a Verilife.] On or about January 1, 2020, MedMen expanded its Evanston dispensary operations, to include the sale and dispensing of recreational (adult use) cannabis, pursuant to all proper and required licenses, permits and certifications from the City of Evanston and the State of Illinois.

*[MedMen currently operates a medical cannabis dispensary at 1132 Lake Street, Oak Park, Illinois 60301, pursuant to State License Disp. No. 000041 ("Oak Park License"), which was issued by IDFPR, as well as a Special Use granted by the Oak Park Zoning Board of Appeals. On or about January 1, 2020, MedMen expanded its Oak Park dispensary operations, to include the sale and dispensing of recreational (adult use) cannabis, pursuant to all proper and required licenses, permits and certifications from the City of Oak Park and the State of Illinois.]

MedMen has executed a long-term lease, with the Property Owner – Weed-Sheffield LLC, with the intent and desire to locate and establish an Adult Use Cannabis Dispensary, within the existing building, at the Subject Site. [Section 17-4-0207] *[The proposed Adult Use Cannabis Dispensary will operate similar to other Retail Establishments, which feature the sale of controlled substances, located within the City of Chicago, and - therefore, the proposed use at this Site will comply with the pertinent provisions of the Chicago Zoning Ordinance, with regard to such use.]

The proposed Adult Use Cannabis Dispensary ("Dispensary") will be established within an existing commercial space, which was formerly occupied and operated by a beauty salon and spa (operated by Aveda). The Operating Premises contains approximately 4,600 square feet of occupiable space. Aside from the interior build-out of the subject space, no new construction is proposed or required.

Once completed, the proposed Dispensary will contain: a large entry vestibule area, which shall include a security check-point, where customers will be required to pass all regulatory entry procedures; a customer consultation room; a large sales floor (showroom), with payment/check-out counter; a management office; a security office; an employee breakroom and lounge; at least two secured cannabis/inventory vaults, which will allow for the onsite processing of orders, along with the safe storage of products, equipment and monies associated with sales; and two restrooms.

The proposed Dispensary will be owned, managed and operated by MME 1001 North Retail LLC – d/b/a MedMen Cannabis Dispensary. MedMen is a publicly traded corporation, which has a principal place of business in Illinois, and presently operates thirty (31) other Cannabis Dispensaries across the United States – including in California, Arizona, Florida, Nevada, Massachusetts and New York, in addition to its two (2) existing Illinois Dispensaries. *[MedMen also currently operates six (6) cannabis cultivation facilities across the United States.] MedMen was established in 2010 and has been actively operating most of its Cannabis Dispensaries since January 2018.

For the new proposed Dispensary, MedMen intends to employ an operating staff of 20 to 35 licensed and trained individuals, which will be generally represented as follows: one General Manager; one Store Manager, four Operating Managers; four Leads (Supervisors), at least four Security Agents; and at least twenty (20) Sales Representatives (Associates). All staff members must be registered/certified, and pass background checks, with the State of Illinois (IDFPR), as well as conduct and meet the minimum amount of training education – each year. [Pursuant to the Illinois' Compassionate Use of Medical Cannabis Pilot Program Act ("the Medical Cannabis Act"), all employees will be properly trained and educated in their respective areas of operation, including all with regard to all applicable HIPPA and FDA guidelines.] MedMen intends and is committed to meet the goals of the City's Department of Business Affairs and Consumer Protection (BACP), by employing a workforce representative of the City in which it is located and operating – which shall include staff members and managers from a wide array of minority groups, with roots here in Chicago.


The proposed Dispensary will operate seven (7) days a week - from 10:00 AM until 9:00 PM. *[The State Ordinance allows for dispensaries to operate from 6:00 AM to 10:00 PM, as a general matter.]


Through its proposed operations, MedMen will dispense and offer for sale a variety of cannabis and other related products, including - without limitation: dried cannabis, edibles, concentrates, and topicals. The proposed Dispensary will operate in a manner consistent with the applicable City of Chicago and State of Illinois regulatory rules and guidelines for the storage, dispensing and destruction of cannabis, and other related activities related thereto.


The proposed Dispensary will meet and/or exceed all applicable security guidelines adopted by the State of Illinois for the safe storage, dispensing, sale and destruction of cannabis. The Dispensary will be equipped with a high-end security camera and surveillance system, as well as high-level security lighting, covering both the inside and outside of the facility. The exterior cameras will cover all areas of ingress and egress, including the public way and designated parking areas. The interior cameras will cover the reception and waiting areas, point-of-sales counters, and inventory (storage) room. The security system will be directly linked to and monitored by a certified third-party security company on an around-the-clock basis, which such information shall also be directly accessed by local law enforcement, the State of Illinois Police Department, and the Chicago Office of Emergency Management and Communications (OEMC).

Entry to the Dispensary will be through a single main door at the front of the building – off of Sheffield Avenue. The entrance will be strictly regulated with cameras and at least one full-time security agent. All inventory (medical cannabis and related products) will be stored in steel (fire-proof and waterproof) safes/vaults within the Operating Premises, which such areas will be strictly limited to authorized staff members of staff - only. These areas will be secured from the remainder of the Operating Premises by security grade glass and automatically locking, electronic-access, doors. All main dispensary and inventory/storage area doors will require keycards and/or electronic pass codes. All deliveries will be effectuated through a highly secured area, at the rear of the building - off of Kingsbury Street, which will also be monitored by the video surveillance system.

Every customer will be required to provide MedMen staff with a current and valid form of photo identification (Driver's License or State ID). No person will be allowed entry to the proposed Dispensary who does not show proof that they are twenty-one (21) years in age or older.
