The following project was reviewed by the PRC:

1. **81 E. Van Buren**

(Historic Michigan Boulevard District – 2nd Ward)

Proposal: Proposed construction of one-story rooftop addition, canopies, and deck

Action: Approved unanimously with the following conditions:

- 1. The massing, siting and configuration of the one-story rooftop addition proposed to be setback 52'-0" from the exterior face of the parapet on the east side of the building and 15'-7" from the exterior face of the parapet on the north and south sides of the building; the large canopy proposed to be setback 28'-5" from the exterior face of the parapet on the east side of the building, 15'-7" from the exterior face of the parapet on the north side and 5'-0" from the exterior face of the parapet on the south side of the building; and the small canopy located behind the proposed addition, with a maximum height of 9'-10" above the top of the historic parapet are approved as submitted;
- 2. The brick for the addition, corrugated metal for the back wall of the small canopy, and black powder-coat finish for the structure of both canopies are approved as proposed; and,
- 3. Attachment details and cut-sheets for the sconces and attachment details for the handrails shall be submitted with the permit application.

2. **2036 W. Thomas**

(Ukrainian Village District – 32nd Ward)

Proposal: Proposed replacement of damaged outer wythe of face brick on the front

façade with salvaged and new brick, and restoration of previously altered

second floor masonry opening.

Action:

Approved unanimously with the following conditions:

- 1. The exterior wythe of masonry at the front facade, much of which is structurally unsound and pitted, may be removed and replaced to match the historic design, masonry coursing, profiles and details of the facade. As proposed, the inner wythe and stone water table shall remain in place and all decorative masonry and other salvageable face brick shall be retained and reinstalled. Any new masonry, where necessary, shall match the historic masonry in size, color, texture, finish, and joint profile. A plan outlining the proposed process of documentation, removal and rebuilding of the masonry shall be submitted with the permit application. Masonry and mortar samples, details of existing and proposed joint widths, as well as a control mock-up on site, shall be reviewed and approved by Historic Preservation staff prior to permit approval;
- 2. The arched masonry window opening at the second floor shall be reconstructed using the neighboring buildings as a model for detailing. The new windows shall be wood or clad-wood, and shall replicate the existing brick molds found on the first floor windows. Window details shall be submitted with the permit plans;
- 3. The new front doors shall match size, configuration and profiles of existing front doors. Existing and proposed drawings shall be submitted with the permit plans; and,
- 4. Reconstruction of the non-historic front stairs and canopy shall be subject to staff review and approval with the permit plans. In general, historic stairs within the district are wood with closed risers with metal pipe railings and newel posts.

3. **203 N.** Wabash

(Old Dearborn Bank Building – 42nd Ward)

Proposal:

Proposed rehabilitation of office building into a hotel including exterior masonry repairs, window and storefront replacement, rooftop addition and other alterations.

Action:

Approved unanimously with the following conditions:

Masonry Facade

- As proposed, replacement masonry, where required, shall match the size, color, profile, finish and texture of the historic masonry. Masonry repair and replacement details shall be included on the permit plans. Material samples shall be submitted for review and approval prior to order and installation;
- 2. As proposed, the new fixed aluminum windows shall match typical historic double-hung wood windows in exterior profiles and dimensions. Window details and finish sample shall be submitted with the permit application;

3. The terra cotta base of the building shall be cleaned with the gentlest means possible. Cleaning product specifications and material safety data sheets shall be submitted with the permit application. A test cleaning sample shall be reviewed and approved by Historic Preservation staff prior to any work;

Storefronts

- 4. The first floor storefront mullions shall incorporate a decorative cap more in keeping with the historic character of the building. Storefront details and finish samples shall be submitted for review and approval with the permit application;
- 5. The main entrance exterior doors shall be revised to incorporate transom panel divisions as seen on the historic interior vestibule and decorative caps as recommended for the storefront mullions;

Awnings, Canopy, Lighting Fixtures and Signage

- 6. As proposed, awnings shall be canvas, triangular, open-ended with a free-hanging valance and shall be attached to the new storefronts rather than the historic terra cotta. Awning details and attachment details shall be submitted with the permit application;
- 7. The canopy proposed above the main entry shall be located above the decorative terra cotta of the entry and below the decorative terra cotta sills of the 2nd floor windows. Canopy details and attachment details shall be submitted with the permit application;
- 8. The cut-sheets, attachment details, and finish of the proposed first floor lighting sconces shall be included with the permit application;
- 9. The proposed exterior architectural lighting of the facades shall be further studied to ensure that lighting fixtures shall not be attached to or damage historic decorative masonry and shall not be located to be visible from the public rights-of-way. Historic Preservation staff shall review final details, fixture cut-sheets and a site mock-up of the lighting scheme prior to permit approval;
- 10. Any proposed signage shall be subject to Historic Preservation staff review and approval when available;

Lobby

- 11. As proposed, as much as possible of the original decorative mullions for the interior vestibule shall be retained and details of the reconstruction process shall be included with the permit application;
- 12. Changes to the historic cigar stand and sprinkler and lighting installation details shall be included with the permit plans;

Rooftop

- 13. The rooftop additions for the 26th-floor terrace and the elevator override shall be no larger or taller than shown in the submitted drawings dated March 15, 2012; and,
- 14. Metal cladding sample shall be reviewed and approved prior to permit approval.
