

## American Rescue Plan Act Project & Expenditure Report Guide July 1 – September 30, 2024

Under Mayor Brandon Johnson, the City of Chicago continues its essential work of supporting residents and communities recovering from the COVID-19 pandemic. By implementing innovative programs funded through this one-time infusion of federal dollars from the American Rescue Plan Act (ARPA), the City is dedicated to maximizing the impact of these funds to help communities recover. This report provides an overview of the latest ARPA obligation and expenditure changes for Quarter 3 2024, followed by view of ARPA obligation and expenditure progress to date for community initiatives.



### **Project Highlights**

#### Neighborhood Broadband Connectivity

Neighborhood Broadband Connectivity has expended over \$4m this quarter of its \$8.9m total allocation. The program aims to increase broadband affordability and accessibility by serving households where lack of internet service impedes learning students. To date, the program has served 25,266 households and an estimated 41,688 Chicago Public Schools students.

#### **Chicago Empowerment Fund**

The Chicago Empowerment Fund has obligated an additional \$32M this quarter to provide direct financial assistance to those impacted by the pandemic. The first round supported residents from 2022- 2023, while a second round will be launching in Fall 2024 to additional households. #### **Rapid Rehousing Program**

The Rapid Rehousing Program utilizes Accelerated Moving Events (AME) to swiftly provide housing for Chicagoans experiencing homelessness, mitigating the health risks associated with COVID-19. The City's <u>OIG found</u> that 94% of 238 encampment residents who attended an AME between November 2020 and May 2022 secured housing. 83% were still housed on October 3, 2023.
