Public Notice is hereby given by the City of Chicago (the "City"), through the Department of Planning and Development (the "Department"), for the proposed disposition of thirty-nine city-owned parcels located in the Near West Side community area for the proposal described below.

Proposed sale of 2503 – 2563 W Lake, and 2522 – 2564 W Maypole to ComEd for the development of a utility substation to support development growth in the near west side of the City of Chicago. The proposed new substation will boost economic growth and improve the surrounding area, encouraging new investment by entities with strong electrical needs.
