I hope that when it's published, DPD includes a version of the menu of options categorized by applicable project type (resi/commercial/industrial) which would make it much easier to read by filtering out options that don't apply. It's also great to see more public health and equity options. Overall definitely feels like projects will be pushed harder to address various aspects of sustainable design and I appreciate that DPD has reserved the right to update/remove strategies when policies change so the SDP will continue being beyond code! I have some questions/comments, if any of these items can be clarified in the final published version: B7, I'm not clear on whether this applies only to mechanical systems or requires eliminating ALL on-site combustion (minus the noted exceptions). C3. Unclear what "other plants" might qualify here. Would a pollinator garden or other intentionally designed habitat be accepted? C4. Is there a minimum area for this landscaping? Previously I have seen high rise projects achieve this with just planters which doesn't seem in line with the intent. If the intent is to have more intensive planting I suggest adding language about a minimum area or planting depth. C7. Would projects with no asphalt paving comply with this by default? F4/5/6/7 - could there be a compliance path for projects with little or no on site parking, e.g. funding a charger installation at on-street parking? Chicago stands as a significant threat to migratory birds, yet it lags behind other cities in implementing necessary bird-friendly regulations. Peer cities have demonstrated that such measures can be incorporated seamlessly into building projects without significant delays or costs. It's imperative that Chicago takes proactive steps to protect the millions of birds passing through our region. Requiring bird-friendly regulards for new constructions and renovations is a modest yet essential measure to safeguard these vital creatures and support the health of our environment. Bird protection must be made mandatory in Chicago's Sustainable Development Policy. The declining bird populations underscore the urgency of this issue, and it's time for the city to lead by example in prioritizing wildlife conservation.

Fully support the proposals EXCEPT the bird protections should be MANDATORY. It's a matter of life and death for animats, while the other issues are not quite as urgent. Bird-friendly glass is more affordable than ever and using it increases costs very little, especially when the building design itself is bird friendly. As the American city that poses the greatest risk to migratory birds, Chicago should be leading efforts to provide bird protections. Instead, peer cities outpace Chicago on this issue while demonstrating these requirements can be implemented with no significant delays or expense to building projects. Requiring bird-friendly measures for new buildings and major renovations through the SDP is a small step toward making a safer city for the millions of birds that travel through our region. These birds play a critical role in the health of the environment, and their declining numbers should impress upon the city the urgency to protect them.

I'm very upset that bird protections aren't mandatory for new buildings. The costs of implementing these protections are minimal and are the least we can do to show respect for the other creatures that share this space. The words "strongly encourages" should be changed to "requires". Requiring bird-friendly measures for new buildings and major renovations through the SDP is a small step toward making a safer city for the millions of birds that travel through our region. These birds play a critical role in the health of the environment, and their declining numbers should impress upon the city the urgency to protect them. Chicago needs to step up and be a leader, not the "second city".

Chicago has an important role to play in the conservation of wildlife in our hemisphere. Millions of birds fly over Chicago every night during the height of their migration between the sub-tropical and tropical forests to our south and the boreal forest and tundra to our north. Many stop over in Chicago. and tens of thousands of them collide with windows and die each year. These birds are not pigeons and house sparrows - they are warblers, flycatchers, hummingbirds, tanagers and other birds, many of whom never see a city, glass, or city lights except on migration. Many are rare or declining. Chicago is the most dangerous city for migrating birds because it is near the river of birds migrating through the middle of our country, and because it generates so much light, which draws birds off their migratory route. In recent years, great strides have been made in making window glass that birds will not collide with - and that people enjoy. This glass adds little to the cost of a building and is getting less expensive all the time as demand grows. Many major cities such as New York, San Francisco and Toronto are requiring this glass in new buildings. Our coalition, Bird Friendly Chicago, has worked with the DPD for 4 years developing model regulations and a guidebook to show developers how to implement them. Skokie and Evanston have taken our work and implemented bird-friendly Regulations. Please make bird-friendly regulations mandatory under the Sustainable Development Policy. I fear that these innocent birds are now caught in the back and forth between city government and developers. Every bird-killing building that goes up adds to the toll on these birds that are also facing habitat loss, cats, pesticides and climate change. This is one problem that we can solve easily. protection will inherently mean that the building is likely <40% glass facade, so one action may be awarded 30 points instead of 20 for basic bird protection or 10 for energy efficiency from reducing glass facades. Bird protection should be a mandatory feature for all buildings. By reducing glass facades and making glass facades that are proposed entirely bird safe glass energy efficiency can be accomplished simultaneously. There should also be requirements that unnecessary lighting is turned off- motion sensors and dark-skies compliant outdoor lighting should be mandatory for energy efficiency, bird migration protection, and reduction of light pollution. Third party certifications get massive points under this system, however there are many cost and marketing based incentives that already encourage developers to pursue receiving LEED or other certifications. Furthermore, it's not clear that these building certifications will have direct impact on Chicagoans versus some of the other menu strategies which will have direct and immediate effects on Chicago. Points for certifications should be lowered or removed. Green roofs should be lowered to 5 points for 50% and 10 points for 100%. I think it's better usage of space to incorporate solar on rooftops rather than create generally inaccessible rooftop garden/patio space which would be primarily a building amenity. Giving points for solar ready roofs but not solar panels themselves, given how relatively infrequently most properties are redeveloped, seems like it will provide developers with points that don't actually result in renewable energy generation. As many more points are given for renewable energy usage, this should be enough to encourage developers to include solar generation. Without getting points for merely preparing a rooftop for solar generation. Tree Health & non toxic pavement sealants are vague but regardless, should be mandatory. Trees that can't develop large canopies or are not expected to have long lifespans are not going to be able to provide the positive effects that urban forestry should have on the city. Productive landscapes should be removed- 500 sq ft is an extremely small plot for food growth, and will only benefit a handful of people. This same space would be put to better use with almost any other usage. EV charging stations are given high value, but this is a typical building amenity that is likely to be lowly used depending on the type of business operating out of a building. Meanwhile, Chicago is falling behind and it increasingly makes national news as a death spot for birds that fly across the globe. To protect wildlife, bird safe building design must be required for all new and remodeled buildings. In April of 2020, City Council passed an Ordinance to Amend Chicago Sustainable Development Policy to include stronger protections for birds. However, after four years of waiting to see those changes, a draft has been released showing that bird safety will be included only as an option amongst many others. With no incentive to protect birds over other important sustainable solutions, birds will continue to die in Chicago despite us having tools to prevent this.

From Experience: we feel that the Third-party Building Certifications (e.g. LEED, Green Globes,) are statistically insignificant in proportion to what the "average" citizen, business or community member can contribute using a common sense approach along with working with the excellent resources of the SDP

A few questions come to mind when reviewing Item D.10. Have studies been conducted to determine how many Type A adaptable units are currently being adapted on new construction projects in Chicago, or to determine if there is a shortage of Type A adaptable units in the local market? Could alternate strategies be considered? For example, could a portion of market rate Type B units be increased in adaptability by providing Type A roll-in showers at those units? I suspect a more nuanced approach such as this could provide occupants with choices more attuned to their needs, and would likely be more financially feasible for the developer. Perhaps other innovative ideas can be explored to accommodate disabilities which are not already accommodated in the current accessibility codes.

Stop allowing the tearing down perfectly good buildings!

Although I think certifications are a great way to hold buildings accountable, getting a certification does not always mean the building is actually performing to the best of its ability. Would like to see some policy that revolves around setting a higher code minimum for buildings, rather than just achieving a certification. N/A

It's vital that bird-safe glass is required, not optional, for new developments and re-developments. The city's Latin name is 'Urb in Horto' or 'City in a Garden'. Bird's colliding into glass and dying or injuring themselves means that they cannot serve as natural predators for insects, and act as magnet for birders who help support the economy.

Protecting natural habitats (and rebuilding those habitats) is of immense importance–not only for birds, but for biodiversity as a whole, for pollinators, for our access to nature, and for our resilience to climate change (ex: restoring wetlands and mangroves mitigates flooding in the surrounding areas). Supporting public health, including access to housing, is also of paramount importance.
