4,945 individuals arrived at O'Hare & Midway

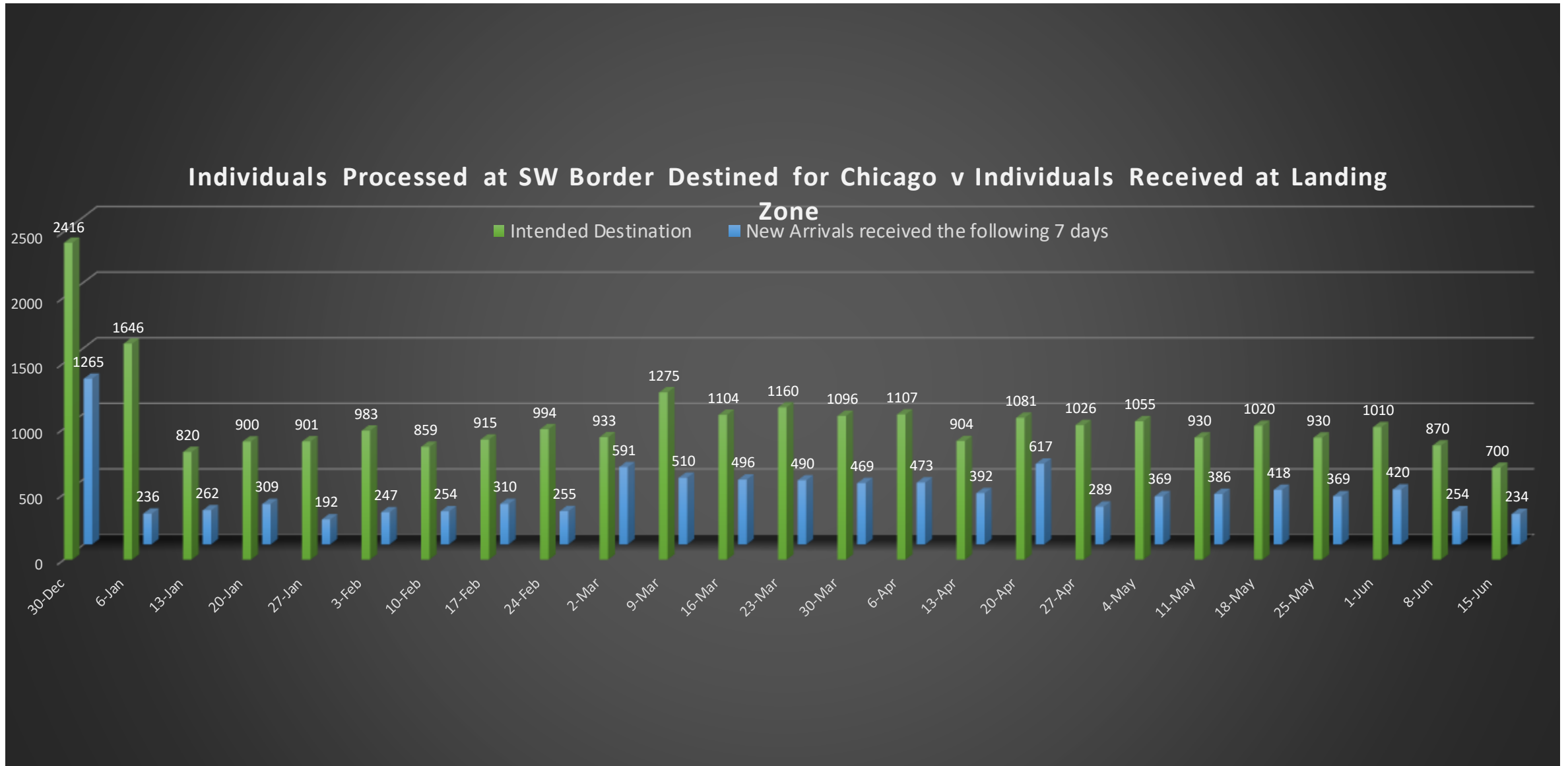

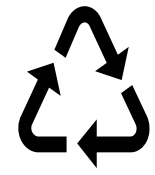

MOCS shelter & community safety overview

EXAMPLE:

Shelter & Community Safety Call Agenda

1. Shelter & Community Safety Committee updates

Large Gatherings

Concern: large gatherings that are brought by vendors, folks wanting to just hang outside which then creates some safety concerns

Ask: Are there any organizations, individuals with access to space?

The Resurrection Project and the State – in collaboration with City and Federal governments, and others – are coordinating efforts to **centralize and expedite application** preparation via large-scale workshops for new arrivals who are eligible for Temporary Protected Status (TPS) and/or Employment Authorization Documents (EAD).

Phase 3 of TPS/EAD Workshops launched June 14:

- Two days per week, daily capacity of 50-60; same location (Metcalf building, 77 W Jackson Blvd)
 - Mondays are reserved exclusively for current shelter residents; Fridays will be a combination of current shelter residents and people living in the community
 - USCIS will be on-site Mondays; shelter residents who register for Friday appointments will have to return on a Monday for USCIS processing

Workforce Development Updates:

Hyde Park Shelter

A former hotel shelter that was previously used to quarantine New Arrivals from measles is serving as a facility for standard shelter operations. State-funded quarantine shelter was decommissioned for quarantine in early May, allowing the State to transition the site to a shelter for families.

Midway Shelter (*New*)

Buildout for the next State-supported shelter at a former hotel on the Southwest side of Chicago began last week. The plan is to begin moving in families in July. This shelter has a maximum capacity of 950 residents.

Little Village Shelter

IDHS opened a State-supported shelter at a former CVS in Little Village at the beginning of the year.

Federal Updates



- On **June 18, 2024**, the Biden administration announced it would **extend access to the Parole-in-Place program to some spouses and stepchildren of U.S. citizens.**
- This program will open doors for certain people to obtain parole and employment authorization, and to potentially become eligible to pursue lawful permanent residence.
- This means that **approximately 500,000 spouses of U.S. citizens.**
- The process will be streamlined to provide employers with the confidence to apply for legal work permits for Dreamers, both with and without DACA.





Who will benefit from the new PIP policy?*

- Individuals who:
 - Are present in the US without admission or parole;
 - Have been legally married to a US citizen as of June 17, 2024; AND
 - Have been continuously and physically present in the US for at least 10 years as of June 17, 2024.
- Stepchildren of the undocumented spouses above who:
 - Have been physically present in the United States without inspection;
 - Are unmarried;
 - Are under the age of 21; AND
 - Were under age 18 when their undocumented parent married their US citizen stepparent

Please note that parole will not waive other bars that block someone from getting a Green Card, such as criminal offenses and document fraud.

***The information above is subject to change as details of the policy are still being finalized.**

USCIS still needs time to implement a process for applications. Applications might not be available for at least 60 days.

Refrain from taking action or paying for legal services until further information is released.

**Know Your Rights: Parole-in-Place for
Spouses and Stepchildren of U.S. citizens**

On June 18, 2024, the Biden administration [announced](#) it would extend access to the Parole-in-Place program to some spouses and stepchildren of U.S. citizens. This program will open doors for certain people to obtain parole and employment authorization, and to potentially become eligible to pursue lawful permanent residence.

NIJC will continue to update this guidance as more details become available about how the administration intends to implement this program. Here are a few things people should know now based on the information currently available:

1. No one can apply yet. The administration still needs to publish notice and instructions about the application process, including the application, fee, and required supporting documents. We expect this will happen later this summer.

2. Who will be eligible: U.S. Citizenship and Immigration Services (USCIS) will consider an individual's eligibility on a case-by-case basis.

Spouses of U.S. citizens must:

- ✓ Be present in the United States without admission or parole;
- ✓ Have been continuously present in the United States for at least 10 years as of June 17, 2024;
- ✓ Have a legally valid marriage to a U.S. citizen as of June 17, 2024; and
- ✓ Have no disqualifying criminal history or otherwise constitute a threat to national security or public safety

Stepchildren of U.S. citizens must:

- ✓ Be present in the United States without admission or parole; and
- ✓ Have a qualifying stepchild relationship to the U.S. citizen as of June 17, 2024

3. What you can do now:

- ✓ Schedule a legal consultation with a trusted legal service organization or immigration attorney to be informed of your options.
- ✓ Gather documents – **The following are only recommended documents.** USCIS has not yet published what documents will be necessary.
 - Identity documents (Your birth certificate, photo identification)
 - Marriage certificate
 - Proof that your spouse is a U.S. citizen (U.S. birth certificate, naturalization certificate, or U.S. passport)
 - Proof of legal termination of any past marriages for you and your spouse (divorce, annulment, death certificate)

- Your children's birth certificates
 - Proof that you have been in the United States from June 18, 2014 to June 17, 2024, including U.S. income tax returns and household bills with your name and U.S. address
 - Certified court dispositions for any criminal arrests
 - Copies of any past immigration applications
- ✓ Save money for the application fee.

4. Avoid Notary Fraud: Applying for this — or any other immigration benefit — carries some risk. A person who applies and does not qualify and/or includes inaccurate information in an application could face negative immigration consequences including: denial of benefits, loss of filing fees, ineligibility for future benefits, and/or referral for deportation proceedings.

As you explore eligibility for this immigration benefit, please keep the following points in mind:

- × No attorney or legal service provider can promise you an outcome on your case. Because we don't have final instructions from the government, it remains unclear who will qualify for this benefit.
- × Because the government has not yet released the full requirements for this program, no one can promise you are eligible for this benefit or guarantee you will be able to receive an employment authorization document. While some attorneys may ask for a fee to assess your case and/or be under contract with you to complete your application if you are eligible, be careful about paying for legal services at this time.
- × Avoid fraud by notaries and other unlicensed providers. Only licensed attorneys and accredited representatives who work at recognized nonprofit organizations can provide a legal assessment of your case or offer you legal services.

TPS HAS BEEN EXTENDED & REDESIGNATED FOR HAITI!!



EVERYTHING YOU NEED TO KNOW ABOUT THE UPDATE



President Biden **extended TPS for another 18 months until February 3, 2026.**

The redesignation of Haiti for TPS **allows an estimated 309,000 additional eligible Haitian nationals** who have been continuously living in the U.S. on or before **June 3, 2024** to file an initial application.

Eligible applicants who already have TPS, must re-register by filing another TPS application (Form I-821) by August 30, 2024 to keep their TPS status.
